1240. Shri Sanjay Kumar Jha:

Will the Minister of Science and Technology be pleased to state:

- (a) whether various State Governments including Bihar have sent proposals for development of Science and Technology (S&T) during last five years and if so, details thereof, State-wise;
- (b) details of proposals approved/rejected during the said period, State-wise including Bihar;
- (c) details of the proposals sent by Bihar and pending with Government including reasons for the same;
- (d) summary of scholarship funds distributed to students and scholars by Ministry during last five years, year-wise and State-wise; and
- (e) whether Government plans to introduce more 'Science Express' trains to educate students/ people about issues like air pollution, green energy and climate change and if so, details thereof?

(a) to (b): The Ministry of Science and Technology, Government of India (GoI) is implementing several Central Sector Schemes on Science and Technology (S&T) on PAN India basis through the Department of Science and Technology (DST), the Department of Biotechnology (DBT) and the Department of Scientific and Industrial Research (DSIR)/ Council of Scientific and Industrial Research (CSIR).

DST under its State Science and Technology Programme (SSTP), nurtures Centre-State Science and Technology (S&T) cooperation through budgetary support to S&T Secretariat of 28 State/Union Territory (UT) Science & Technology Councils including the state of Bihar for catalysing the Science Technology and Innovation (STI) ecosystem at State/UT level through systemic interventions under the six components of the STI ecosystem. These components include Research & Development; Institutional & Human Capacity Building; Innovation; Technology deployment for socio-economic development; Science communication and popularization & State policies. DST provides Grant-in-Aid annual support to S&T Councils towards assistance to their S&T Secretariats and Patent Information Centres (PIC) established at the Councils, based on the proposals received from the Councils. The details of proposals received from the State Science and Technology Councils and approved/rejected by DST during the last five years is annexed as Annexure-I.

The details of proposals received from State Governments and approved/rejected by DST and DBT for development of Science and Technology (S&T) during the last five years are annexed as Annexure-II.

- (c) There are no proposals from the Bihar Government pending with the Ministry.
- (d) The details of scholarship funds distributed to students and scholars by DST, DBT and DSIR/CSIR are given at Annexure-III.
- (e) Ministry of Science and Technology has no approved plan to introduce more "Science Express" trains.
