THEME BASED CIRCUITS IN BIHAR

1252 SHRI SANJAY KUMAR JHA:

Will the Minister of **TOURISM** be pleased to state:

- (a) the details of the theme based circuits in Bihar and funds sanctioned thereof under the Swadesh Darshan scheme;
- (b) whether Government would consider including more circuits under the Swadesh Darshan Scheme in the country especially under the Buddhist themes, if so, the details thereof:
- (c) whether it is a fact that a large number of young artists are getting benefits from Government across the country since the last five years under the scheme 'Scholarships to Young Artists'; and
- (d) if so, the details thereof?

ANSWER

THE MINISTER OF TOURISM

(SHRI GAJENDRA SINGH SHEKHAWAT)

(a) to (b): While development and promotion of tourism destinations and products is primarily undertaken by the concerned State Government (SG)/Union Territory Administration (UT), the Ministry of Tourism through its central sector schemes of 'Swadesh Darshan (SD)' and 'Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' complements the efforts of tourism infrastructure development by extending financial assistance to the State Governments/Union Territory Administrations including the State of Bihar in synergy with the scheme guidelines, availability of funds etc. The Ministry of Tourism has sanctioned 5 projects under its 'Swadesh Darshan' and 2 projects under its 'PRASHAD' schemes in the State of Bihar.

Ministry of Tourism has further revamped the Swadesh Darshan Scheme as Swadesh Darshan 2.0 (SD2.0) with the objective to develop sustainable and responsible tourism destinations and has identified 'Gaya' and 'Nalanda' as destinations in the State of Bihar for development.

Government of India has also sanctioned 2 tourism projects in Bihar under the 'Scheme for Special Assistance to States for Capital Investment 2024-25' (SASCI).

The list of Sanctioned projects under Swadesh Darshan, PRASHAD and SASCI is annexed.

(c) & (d): Centre for Cultural Resources and Training (CCRT), Ministry of Culture being an autonomous organization under the aegis of Ministry of Culture, Government of India, implementing scholarship and fellowship schemes for preservation and promotion of

diverse, varied and rich Indian cultural heritage which is being manifested through various performing, literary and visual art forms.

The Scheme for "Award of Scholarships to Young Artistes (SYA) in Different Cultural Fields" has also been transferred to CCRT partially in the year 2014 under which 400 scholarships are provided in the age group of 18 to 25 years in the field of Indian Classical Music, Classical Dances, Light Classical Music, Theatre, Visual Arts and Folk/ Traditional and Indigenous Arts for advance training. Each scholar is paid Rs.5000/- (₹. Five thousand only) per month for a period of two years to cover his/her living expenses on travelling, books, art material or other equipment and tuition or training charges etc. The details are as under:
