# FUNDS FOR PROMOTION OF TOURISM

## 1254 SHRI NARESH BANSAL:

Will the Minister of **TOURISM** be pleased to state:

- (a) the details of the assistance being extended to the State Government of Uttarakhand by the Central Government keeping in mind the immense opportunities of tourism;
- (b) the details of the approved budgetary allocations to promote tourism in Uttarakhand during the last five years, scheme wise and district-wise; and
- (c) whether Government proposes to formulate any scheme for increasing the number of tourists in different districts of Uttarakhand?

## THE MINISTER OF TOURISM

## (SHRI GAJENDRA SINGH SHEKHAWAT)

(a) to (c): While development and promotion of tourism destinations and products is primarily undertaken by the concerned State Government (SG)/Union Territory Administration (UT), the Ministry of Tourism through its central sector schemes of 'Swadesh Darshan (SD)' and 'Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' complements the efforts of tourism infrastructure development by extending financial assistance to the State Governments/Union Territory Administrations including the State of Uttarakhand in synergy with the scheme guidelines, availability of funds etc. The Ministry of Tourism has sanctioned 2 projects under its 'Swadesh Darshan' and 3 projects under its 'PRASHAD' schemes in the State of Uttarakhand.

Ministry of Tourism has further revamped the Swadesh Darshan Scheme as Swadesh Darshan 2.0 (SD2.0) with the objective to develop sustainable and responsible tourism destinations and has sanctioned 2 projects in the State of Uttarakhand.

Government of India has also sanctioned one tourism project in Uttarakhand under the 'Scheme for Special Assistance to States for Capital Investment 2024-25' (SASCI).

The list of Sanctioned projects under Swadesh Darshan, PRASHAD, SD 2.0 and SASCI in the State of Uttarakhand is annexed.

The Ministry of Tourism promotes India in a holistic manner, as a tourist destination, through various initiatives including promotional events, assistance to State Governments for organizing fairs and festivals, etc. The Ministry also promotes various tourist destinations including Uttarakhand and its products through its website and social media.
