PLANS FOR NATURAL GAS PIPELINES

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) the status of India's domestic petroleum reserves (Provisional) as per PRMS as on 30th September 2024;
- (b) whether Government has data regarding the exploration being conducted at possible petroleum reserves of the country and if so, the details thereof;
- (c) the total quantity of various petroleum products being imported and exported from the country to other countries, the detail thereof;
- (d) whether Government proposes to set up a natural gas pipeline with foreign countries and if so, the details thereof; and
- (e) the details of the natural gas pipelines existing in the country and proposed new ones as on 30th September 2024?

(a) The status of India's domestic petroleum reserves (Provisional) as per Petroleum Resources Management System (PRMS) (as on 01.04.2024)* are as follows:

- * The domestic petroleum reserve status in the country is calculated once a year as per Petroleum Reserves Management System (PRMS).
- (b) Exploration for oil and gas in the country continues through acreages awarded under nomination and contractual regimes. After adoption of Hydrocarbon Exploration Licensing Policy (HELP) in 2016, during the 8 rounds of Bidding under the Open Acreage Licensing

Programme (OALP), till date 144 exploration blocks covering an area of 2,42,056 Sq. KM have been awarded, which have attracted a total investment of approximately USD 3.37 Billion. Notably, during fiscal year 2023-24 a total of 132 exploratory/appraisal wells were drilled across different regimes resulting in the accretion of 14.2 MMT of oil and condensate and 35.6 BCM of natural gas.
