GAS PIPELINE PROJECT IN BIHAR

135. DR. BHIM SINGH:

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) The number of cities connected with a gas pipeline project or city gas distribution project in the State of Bihar;
- (b) the percentage of the cities of Bihar where piped gas can be supplied for domestic use, number of areas proposed to be supplied and the number of cities where supply is beingmade till date, area-wise;
- (c) the details of amount sanctioned and disbursed by Government for the said projectduring the last five years, year-wise; and
- (d) the target date of completion of city-wise project and the amount sanctioned for thesaid purpose, the details thereof?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SURESH GOPI)

(a) to (d) Providing Piped Natural Gas (PNG) connections, establishment of CNG stations and laying of pipeline infrastructure is part of development of City Gas Distribution (CGD) Networks and the same is carried out by the entities authorised by Petroleum and Natural Gas Regulatory Board (PNGRB). PNGRB has authorised 14 Geographical Areas (GAs)(including 3 GAs spread over Bihar & Jharkhand and 1 GA spread over Bihar & Uttar Pradesh) covering entire state of Bihar. The GA-wise details including date of target completion in the state of Bihar, as on 31.08.2024 is at Annexure.

No fund is released by the Government for CGD projects. The project cost for CGD projects are borne by the concerned CGD entities as per their Minimum Work Plan and technocommercial feasibility.
