PROGRESS OF DAY-NRLM IN GOA

1420 SHRI SADANAND MHALU SHET TANAVADE: SHRI MAYANKBHAI JAYDEVBHAI NAYAK:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the progress made under the Deen-Dayal-Antyodaya-Yojana-National Rural Livelihood Mission (DAY-NRLM) in the country including Goa;
- (b) whether the said mission is effectively transforming the lives of the rural population in the country including Goa, if so, the details thereof;
- (c) the key performance indicators used to assess the progress of DAY-NRLM, specifically in Goa and the manner in which these metrics reflect the mission's impact on rural households; and
- (d) whether the physical and financial progress of DAY-NRLM, in the country including Goa is being regularly updated on the official portal, if so, the details of the latest updates for the State?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (DR. CHANDRA SEKHAR PEMMASANI)

(a): The Ministry is implementing Deendayal Antyodaya Yojana – National Rural Livelihoods Mission (DAY – NRLM) across the country (except Delhi & Chandigarh) with the objective of organizing the rural poor women into Self Help Groups (SHGs) and continuously nurturing and supporting them till they attain appreciable increase in income over a period of time and improve their quality of life and come out of abject poverty. As of 31st October, 2024 the Mission is being implemented in 7138 blocks in 742 districts across 28 States and 6 UTs. Cumulatively, 10.05 crore women have been mobilized into more than 90.87 lakh SHGs. The details of achievements made under DAY-NRLM including Goa are at **Annexure-I.**

(b): DAY-NRLM is a comprehensive initiative designed to empower rural women and enhance their livelihoods. The Ministry has commissioned several impact evaluation studies to understand the overall impact of DAY-NRLM. An impact evaluation study of DAY-NRLM was conducted during 2019-20 by the International Initiative for Impact Evaluation (3ie) with the support of the World Bank. The assessment covered 9 States with around 27,000 respondents and 5,000 SHGs across Bihar, West Bengal, Odisha, Jharkhand, Madhya Pradesh, Chhattisgarh, Maharashtra, Rajasthan and Uttar Pradesh. The evaluation indicates that an additional exposure to the Mission for 2.5 years led to:

- i. Increase in income by 19% over the base amount.
- ii. Decline in share of informal loans by 20%
- iii. Increase in savings by 28%
- iv. Improved labour force participation proportion of females reporting secondary occupation is higher (4%) in treatment areas.
- v. Improved access to other Schemes Significant increase in number of social schemes availed by treatment households (6.5% higher over the base value of 2.8 schemes).

(c): The key performance indicators on which the DAY-NRLM is assessed including in the State of Goa are at **Annexure II.** These parameters indicate the strength of institutions, level of financial inclusion, livelihoods activities and the social inclusion activities that have been undertaken under DAY NRLM.

(d): The State-wise physical and financial progress is regularly updated on the official MIS portal of DAY NRLM which can be seen at <u>http://nrlm.gov.in</u>.
