## 1456. SHRI R. DHARMAR

Will the Minister of CIVIL AVIATION be pleased to state:-

(a) the objectives of the Krishi UDAN scheme;

(b) the number of flights and airports covered under the Krishi UDAN scheme since its launch, and total volume of agricultural produce transported through this scheme to date;

(c) the details of funds allocated and spent on Krishi UDAN scheme during the last three years within Tamil Nadu;

(d) the steps taken by Government to address logistical challenges, such as cold storage facilities, cargo handling and cost of air transport, to make the Krishi UDAN scheme more effective for farmers; and

(e) whether there are any plans to include exports of agricultural products under this scheme?

### ANSWER

# MINISTER OF STATE IN THE MINISTRY OF CIVIL AVIATION

(Shri Murlidhar Mohol)

(a) The Krishi Udan Scheme aims to ensure seamless, cost effective, timebound air transportation and associated logistics for all Agri-produce originating especially from Northeast, hilly and tribal regions of the country, so that it improves their value realisation.

Krishi Udan Scheme is a convergence scheme where eight Ministries/Departments namely Ministry of Civil Aviation, Department of Agriculture & Farmers' Welfare, Department of Animal Husbandry and Dairying, Department of Fisheries, Ministry of Food Processing Industries, Department of Commerce, Ministry of Tribal Affairs, Ministry of Development of North-Eastern Region would leverage their existing schemes to strengthen the logistics for transportation of Agri-produce.

(b) The Krishi Udan Scheme covers 58 airports in the country, primarily focusing on 25 airports in North Eastern, Hilly and Tribal region besides 33 airports in other regions/areas. The list of airports is at annexure.

All perishable commodities are covered under Krishi Udan Scheme in the country which includes horticulture, fishery, livestock and processed products.

(c) There is no specific budget allocation under Krishi Udan Scheme.

(d) For facilitating and incentivising movement of agri-produce by air transportation, waiver of Landing charges, Parking charges are provided for Indian freighters and P2C (Passenger-to-Cargo) Aircraft by Airports Authority of India (AAI) and Ministry of Defence at their selected Krishi Udan airports. In addition, Route Navigation Facility Charges (RNFC) and Terminal Navigational Landing Charges (TNLC) are waived off at the selected AAI airports.

Presently, cold storage facility is available at 35 airports in India namely, Agartala, Ahmedabad, Amritsar, Bagdogra, Bengaluru, Bhopal, Bhubaneswar, Chennai, Coimbatore, Delhi, Goa, Goa Mopa, Guwahati, Hubballi, Hyderabad, Indore, Jaipur, Kannur, Kochi, Kolkata, Kozhikode, Lucknow, Madurai, Mangaluru, Mumbai, Nagpur, Nashik, Port Blair, Ranchi, Srinagar, Surat, Thiruvananthapuram, Tiruchirappalli, Varanasi, and Visakhapatnam.

(e) All perishable commodities are covered under Krishi Udan Scheme in the country originating from the 58 Krishi Udan airports, especially from Northeast, hilly and tribal regions of the country, which includes horticulture, fishery, livestock and processed products.
