#### NEW DEVELOPMENT SCHEMES FOR MADHYA PRADESH

Will the Minister of PLANNING be pleased to state:

- (a) whether the NITI Aayog has launched any new development schemes for Madhya Pradesh;
- (b) if so, the details thereof, district-wise; and
- (c) the details of funds released during the last three years, scheme-wise?

#### **ANSWER**

(a), (b) & (c) NITI Aayog is the premier policy think tank, providing directional and policy inputs to the government. It has been given the responsibilities of running three schemes, i.e. Aspirational District Programme/Aspirational Block Programme, Atal Innovation Mission and State Support Mission, as these schemes have a strong element of cooperative and competitive federalism. It does not run and has not launched any state specific scheme.

## (i) Aspirational Districts Programme (ADP)-

The Aspirational districts programme was launched in January 2018 by the Government of India with the aim to improve the social outcomes of the relatively underdeveloped districts of India. Under the ADP Programme, efforts are being made to bring rapid transformation across 5 sectors i.e Health & Nutrition, Education, Financial Inclusion & Skill Development, Agriculture & Water Resources and Basic Infrastructure. Barwani, Chhatarpur, Damoh, Guna, Khandwa, Rajgarh, Singrauli and Vidisha districts of Madhya Pradesh are part of ADP. Funds are released

as awards in most cases for good performance or occasionally for innovative projects submitted by ADP districts.

## Aspirational Blocks Programme (ABP)-

The Aspirational Blocks Programme was launched in January 2023 by the Government of India with the aim to improve the social outcomes of the relatively underdeveloped blocks of India. There are 500 aspirational blocks across 329 districts across India under the Programme with an aim to bring about rapid transformation across 5 key sectors being covered under the ADP Programme within the various aspirational blocks.

The blocks of Madhya Pradesh which are part of ABP programme and funds allocated are as per **Annexure-I.** 

#### (ii) Atal Innovation Mission (AIM):

AIM, NITI Aayog is Government of India's flagship initiative to promote a culture of innovation and entrepreneurship in the country. AIM envision to create a vibrant ecosystem of innovation and entrepreneurship in India and develop an institutional structure to support innovations through the innovation value chain and lifecycle.

AIM realizes its vision through an implementation framework comprising of various programs:

- 1. Atal Tinkering Labs (ATLs) in schools
- 2. Atal Incubation Centres (AICs) an ecosystem of start-ups and entrepreneurs
- 3. Atal Community Innovation Centres (ACICs) grassroots innovation in underserved regions of the country
- 4. Atal New India Challenges (ANICs) innovations with national impact

The details of these programs being implemented across the country along with status of each in Madhya Pradesh and funds allocated are as per **Annexure-II**.

(iii) State Support Mission: SSM is a demand driven scheme and the objective of SSM is to strengthen and institutionalize the on-going engagement of NITI Aayog with states and UTs. NITI Aayog will assist interested states/UTs to establish State Institution for Transformation (SIT) or reimagine the role of existing State Planning Departments/Boards that can act as a multi-disciplinary resource to steer the development strategies in the States/UTs and support to State/UTs. No funds have so far been released to Madhya Pradesh.
