- (a) the number of Micro, Small and Medium Enterprises that were started during the last five years, the details thereof, State-wise/UT-wise;
- (b) the number of persons who got employment in this sector during this period, the details thereof, State-wise/UT-wise;
- (c) the number of MSMEs that were granted permission in Kerala during the last five years;
- (d) the details of the investments made in SMEs in Kerala in the said period?

(a) & (b): Udyam Registration Portal has been launched on 01.07.2020. As on 30.11.2024, the number of Micro, Small and Medium Enterprises incorporated on the Udyam Registration Portal since inception is **1.59 crore** and the total employment reported by the MSMEs is **9.52 crore**. State/UT-wise details given in Annexure-I.

(c) & (d): The Udyam Registration Portal is an online portal for MSMEs which is voluntary and based on self-declaration of information. As per Udyam Registration Portal, the total number of registered SMEs and investment during the last five years in Kerala state is given below:
