### **ROYALTIES FROM NON-COAL MINERALS FROM ODISHA**

#### 1546 SHRI MUZIBULLA KHAN:

Will the Minister of MINES be pleased to state:

- (a) the total royalties collected from non-coal minerals during the last three years;
- (b) the share of Odisha in these royalties and their allocation for development projects; and
- (c) the steps being taken to enhance royalty collections and ensure fair compensation for mineral-rich States?

#### ANSWER

# THE MINISTER OF COAL AND MINES (SHRI G. KISHAN REDDY)

(a) The royalty in respect of minerals, both major and minor including non-coal are collected and retained by the State Government concerned. The data regarding collection of royalty is not maintained centrally. As per the information received from the State Governments, the State wise royalty accrual on Minerals (Other than Coal, Lignite, Sand for Stowing and Minor Minerals) during 2021-22 to 2023-24 is at **Annexure – I.** 

(b) As per the information provided by the State Government of Odisha, the royalty collected from non-coal minerals (including Sand for Stowing and Minor Minerals) is Rs.18,209.643 crore in 2021-22, Rs.10,875.458 crore in 2022-23 and Rs.14,305.138 crore in 2023-24. However, there is no specific information on allocation of royalties for development projects in the State.

(c) The responsibility of collection of royalty lies with the respective State Government. The royalty collection of a State depends on the extent of mineral production in the State and not on any compensation. The Mines and Minerals (Development & Regulation) Act, 1957 was amended in 2015 whereby auction regime was introduced for grant of mineral concessions. After the introduction of the auction regime, State Governments receive auction premium in addition to Royalty.
