Jan Aushadhi Kendras in Tamil Nadu.

1621 Shri C. Ve. Shanmugam:

Will the Minister of Chemicals and Fertilizers be pleased to state:

(a) whether Government has proposed to open Jan Aushadhi Kendras in every district of the country;(b) if so, the details thereof and if not, the reasons therefor;

(c) the action plan formulated to increase their number especially in rural areas, particularly in Tamil Nadu;

(d) the present status of such kendras set up in the State of Tamil Nadu, district-wise;

(e) whether Government is planning to include more medicines in these kendras; and

(f) if so, the details thereof and if not, the reasons thereof?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS & FERTILIZERS (SMT. ANUPRIYA PATEL)

(a) & (b): Jan Aushadhi Kendras (JAKs) are opened by inviting applications from individual entrepreneurs, NGOs, societies, trusts, firms, Private Companies, etc. While opening these Kendras, a 1 km distance is maintained between two Kendras. Online applications have been invited from all districts of the country through the website <u>www.janaushadhi.gov.in</u>. So far, 776 districts out of 783 districts of the country have already been covered.

(c): To increase access to medicines in rural areas, the Pharmaceuticals & Medical Devices Bureau of India (PMBI), the implementing agency of PMBJP has partnered with the Cooperative sector to open Jan Aushadhi Kendras through Primary Agriculture Cooperative Societies(PACS). Till 30th November 2024, more than 2690 PACS have been given initial approval and 687 Kendras have been opened in PACS. There is no State/UT-wise target for the opening of new JAKs.

(d): Till 30.11.2024, a total of 1300 Jan Aushadhi Kendras have been opened in Tamil Nadu. The district-wise number of JAKs opened in Tamil Nadu is enclosed as **Annexure**.

(e) & (f): Under PMBJP 2047 types of medicines and 300 surgicals devices have been brought under the product basket covering all major therapeutic groups such as Cardiovascular, Anti-cancers, Anti-diabetics, Anti-infectives, Anti-allergic, Gastro-intestinal medicines, Nutraceuticals, etc. New medicines are added to the product basket of PMBJP regularly.
