SHORTAGE OF HOSPITALS AND LACK OF RESOURCES IN RURAL AREAS

1703. DR. M. THAMBIDURAI:

Will the **MINISTER OF HEALTH AND FAMILY WELFARE** be pleased to state:

(a) whether it is a fact that there is shortage of hospitals, particularly in rural areas of the country, with many existing hospitals lacking even basic equipment and resources;

(b) if so, the measures taken to improve the accessibility of healthcare in rural areas;

(c) the details of hospital beds per 1000 population and the percentage of these beds in rural areas, State-wise;

(d) whether Government has any proposal to increase the number of medical seats in the States; and

(e) if so, the details of steps proposed to be taken in this regard?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI PRATAPRAO JADHAV)

(a) to (c): The Ministry of Health and Family Welfare provides technical and financial support to the States/UTs to strengthen the public healthcare system, based on the proposals received in the form of Programme Implementation Plans (PIPs) under National Health Mission. Government of India provides approval for the proposal in the form of Record of Proceedings (RoPs) as per norms & available resources.

As per IPHS norms, Primary Health Centre (PHC) with 6 indoor/ observation beds is to be established to cover 20,000 to 30,000 population, Community Health Centres (CHC) with 30 beds to cover population of 80,000-1,20,000, Sub-District Hospitals with 31-100 beds to cover population of 1,00,000 - 5,00,000 and District Hospital with 101-500 beds to cover population upto 30,00,000.

Health Dynamics of India (HDI) (Infrastructure & Human Resources),2022-23 is an annual publication, based on Health care administrative data reported by States/UTs. Details of health facilities functioning in rural areas, available resources, including the shortages can be assessed at the following link of HDI 2022-23:

Further, as per the report of Health Dynamics of India 2022-23, the States/Union Territories (UTs) wise position of beds at PHC, CHC, Sub District Hospital, District Hospital and Medical Colleges in India as on 31.03.2023 is attached as **Annexure I.**

In 2018, the Government of India announced 1,50,000 Ayushman Bharat Health and Wellness Centres (AB-HWCs) to be established by December 2022. The existing Sub Centres and Primary Health Centres in both rural and urban areas are transformed into Ayushman Arogya Mandir (AAM) to deliver Comprehensive Primary Health Care that includes preventive, promotive, curative, palliative and rehabilitative services which are universal, free and closer to the community, it will improve the assess to quality care in the rural areas.

The Fifteenth Finance Commission (FC-XV) has recommended grants through local governments for specific components of the health sector to the tune of Rs. 70,051 crores and the same have been accepted by the Union Government. These grants for health through Local Governments will be spread over the five-year period from FY 2021-22 to FY 2025-26 and will facilitate strengthening of health system at the grass-root level.

PM-Ayushman Bharat Health Infrastructure Mission (PM-ABHIM) is one of the largest Pan-India scheme with an outlay of Rs. 64,180/- crores for strengthening health care infrastructure to effectively manage and respond to any future pandemics and outbreaks across the country. The CSS components of the scheme are implemented by following the existing framework, institutions and mechanisms of the National Health Mission by leveraging the existing institutional structures available at central and State levels.

Further, to improve access to quality healthcare services in remote and rural areas support for Mobile Medical Unit(MMU) is provided to States/UTs, based on the requirements posed by them in their Programme Implementation Plans (PIPs), subject to availability of resources. Deployment of MMUs is based on a normal population norm with 1 MMU per 10 lakhs population.

Also, Ministry of Health and Family Welfare has developed eSanjeevani, a telemedicine application, which provides doctor to doctor (HWC module) and patient to doctor consultation services (OPD module). This application works on a hub and spoke model. At hub level, a specialist doctor provides services to Health and Wellness Centers (HWCs) in rural areas.

(d) to (e) There is an increase of 102% in Medical Colleges in the country from 387 in 2014 to 780 as of now. There is also an increase of 130% in MBBS seats from 51,348 in 2014 to 1,18,137 as of now and increase of 135% in PG seats from 31,185 in 2014 to 73,157 as of now.
