Immoveable Properties donated to the Aligarh Muslim University (AMU)

188 Shri Ramji Lal Suman:

Will the Minister of EDUCATION be pleased to state:

- (a) whether properties in the form of lands and buildings have been donated in different parts of the country by well-wishers of the University since the establishment of AMU in December, 1920;
- (b) if so, the details of such properties district-wise indicating name of the donor, the mode of transfer i.e. by gift or waqf etc., area of each such property and how such properties are being utilised for the benefit of the institution; and
- (c) the mechanism for managing such properties by the University?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF EDUCATION (DR. SUKANTA MAJUMDAR)

(a) and (b) Yes, immovable properties in the form of lands and buildings have been donated in different parts of the country by well-wishers of the Aligarh Muslim University (AMU) since the establishment of AMU in December, 1920. The details of such properties are enclosed as Annexure.

(c) As per Statute 17 (2) (v) of the Aligarh Muslim University, Aligarh, Act XL of 1920, the Executive Council of the University has the power to manage, regulate and administer all the affairs of the immovable properties of the University. As per Chapter-II of the Ordinances (Executive) read with Section 16 (3-D) and Statute 6 of the University, the Finance Officer is the custodian of all immovable properties of the University.
