**POSHAN ABHIYAAN-NNM**

1919. DR. V. SIVADASAN:

Will the Minister of Women and Child Development be pleased to state:

- (a) the amount of money spent for Poshan Abhiyaan-National Nutrition Mission (NNM) scheme in the last five years, State-wise year-wise data;
- (b) the number of beneficiaries under Poshan Abhiyaan-NNM schme for the last five years, State-wise, year-wise details of the number of beneficiaries; and
- (c) the amount currently due to be paid to the States, the details thereof, State-wise?

**ANSWER**

(SHRIMATI SAVITRI THAKUR)

(a) to (c) Poshan Abhiyaan [erstwhile National Nutrition Mission (NNM)] was launched in March 2018. Under the 15th Finance Commission, various components like Anganwadi services, Poshan Abhiyaan and Scheme for Adolescent girls (of 14-18 years in Aspirational Districts and North-Eastern region) have been subsumed under the umbrella Mission Saksham Anganwadi and Poshan 2.0 (Mission Poshan 2.0) to address the challenge of malnutrition.

Mission Poshan 2.0 has a total financial implication of ₹1,81,703 crore, comprising ₹1,02,031 crore as Central share and ₹79,672 crore as State share for the 5 years period starting from FY 2021-22 till FY 2025-26. Grants are being released based on inputs from States/UTs including the funds requirement and the actual expenditure incurred by States, their Statement of Expenditure (SoE), Utilization Certificates (UCs) and Single Nodal Account (SNA) compliances as per guidelines.

Details of funds released to the States/UTs are at **Annexure – I**.

The State wise number of beneficiaries under this Mission for the last three years is at **Annexure- II**.
