PERFORMANCE OF FPOs

2083. DR. KANIMOZHI NVN SOMU:

Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

- (a) whether it is a fact that Farmer Producers Organisations (FPOs) perform better under women;
- (b) if so, the steps taken to promote the participation of women in FPOs;
- (c) the steps taken by Government to promote FPOs; and
- (d) the list of the number of FPOs set up in the country, State-wise?

ANSWER

THE MINISTER OF STATE FOR AGRICULTURE AND FARMERS WELFARE (SHRI RAMNATH THAKUR)

(a) & (b): Under the Central Sector Scheme for "Formation and Promotion of 10,000 Farmer Producer Organizations (FPOs)", the focus is to include small, marginal and landless tenant farmers. Women farmer's participation as FPO shareholder is preferred under the scheme. No study has been conducted by the Department to ascertain comparative performance of FPOs under women. Further, as per the operational guidelines of the scheme, there shall be adequate representation of women farmer member(s) and there should be a minimum of one woman member in the Board of Directors and Governing Body.

As on 30.11.2024, 1402 women centric FPOs (FPOs having more than 50% women farmer shareholders) have been formed under the 10,000 FPOs scheme. As on 30.11.2024, there are 26.17 lakh beneficiary farmers in the FPOs, out of which 9.72 lakh are women beneficiaries (37.14%). In order to encourage women's participation, besides the mandatory BoD representation, CBBOs mobilise women farmers in the field to become shareholders.

- (c): Under the Scheme for "Formation and Promotion of 10,000 Farmer Producer Organizations (FPOs)" financial assistance for FPO management cost upto Rs.18 lakh per FPO over a period of 3 years is provided. Also Matching Equity grant upto Rs.2,000 per farmer member of FPO with a limit of Rs.15 lakh per FPO and a credit guarantee facility upto Rs.2 crore of project loan from eligible lending institutions also supported. Training and marketing support to the FPO by Cluster Based Business Organizations (CBBOs) is for a period of five years.
- (d): The State-wise list of registered FPOs under the Central Sector Scheme for "Formation and Promotion of 10,000 Farmer Producer Organizations (FPOs) is at Annexure.
