## RAJYA SABHA UNSTARRED QUESTION No. 2151 ANSWERED ON 13<sup>TH</sup> DECEMBER, 2024

#### PROMOTION OF FOOD PROCESSING ENTERPRISES UNDER PMFME SCHEME

#### 2151. SHRI MANAS RANJAN MANGARAJ:

Will the Minister of *FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) the total number of Micro Food Processing Enterprises assisted under the PMFME Scheme, State-wise, including Odisha;
- (b) whether Government has identified specific clusters for food processing development in Odisha;
- (c) the measures taken to provide access to modern technology and marketing support for food processing enterprises under this scheme; and
- (d) whether Government is collaborating with State Governments to address financial and logistical challenges faced by micro food processing units?

#### **ANSWER**

## THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI RAVNEET SINGH)

- (a). Under the "Pradhan Mantri Formalisation of Micro food processing Enterprises (PMFME)" Scheme, loans for 1,08,580 micro food processing units have been sanctioned through credit linked subsidy support. Seed capital Assistance has been provided for 3,10,121 SHG members with amount of Rs. 1032.31 Cr. For the State of Odisha, 1,684 loans have been sanctioned and 26,905 SHG members have been assisted with Seed Capital Support for amount of Rs. 77.6 Cr. The State-wise details including for the State of Odisha is at **ANNEXURE-I.**
- (b). Under the PMFME scheme of the Ministry of Food Processing Industries, the Scheme adopts One District One Product (ODOP) approach to reap the benefit of scale in terms of procurement of inputs, availing common services and marketing of products. ODOP for the scheme will provide the framework for value chain development and alignment of support infrastructure. The ODOP approach of the Scheme leads to ease in providing common facilities and other support services in the identified cluster of ODOP. There may be more than one cluster of ODOP product in one district. There may be cluster of ODOP product consisting of more than one adjacent district in a State. The district wise list of ODOP for the State of Odisha is at **ANNEXURE-II**. Under the Operation Greens scheme of the Ministry, specific clusters for two vegetables namely tomato and okra were identified for food processing development in Odisha. Details are as under:

- (c). Under the PMFME Scheme, financial assistance is being provided to micro food processing enterprises for acquiring new technologies and upgrading equipment. The Capacity Building component of the PMFME Scheme envisages to provide Food Processing Entrepreneurship Development Programme Training to the new and existing micro-food processing individuals taking benefits under the scheme. Two Institutes under MoFPI, viz., National Institute of Food Technology Entrepreneurship & Management, Kundli (NIFTEM-K) and National Institute of Food Technology Entrepreneurship & Management, Thanjavur (NIFTEM-T), in partnership with State Level Technical Institutions, provide training and research support to the selected enterprises/groups/clusters. Under the Marketing & Branding component of PMFME Scheme, Grant upto 50% for Branding and Marketing to groups of FPOs/ SHGs/ Cooperatives or an SPV of micro food processing enterprises. The component provides support in areas such as packaging & branding, quality control, standardization, and food safety adherence for consumer retail sales providing benefit to the Self-help Groups (SHGs), Farmer Producer Organisations (FPOs), and Micro Enterprises engaged in the processing of food products but lack market access and are unable to compete with large market players. Moreover, under the common brand, the microenterprises also benefit from the Branding and Market linkages through handholding support in processing, packaging, supply chain and logistics, and marketing ensuring that the product is available at the retail sales channels.
- (d). The challenges faced by the micro enterprises in implementation of the PMFME Scheme are discussed and resolved through regular follow up/review meetings with States/UTs, lending banks, concerned Ministries/Departments and other stakeholders. In addition, handholding support is provided to the beneficiary for project formulation, execution, access to credit, linkages to machine/equipment manufacturers, maintenance of hygiene & quality control etc.
