FOOD PROCESSING PARKS IN ODISHA

2154. SHRI NIRANJAN BISHI:
DR. SASMIT PATRA:

Will the Minister of ***FOOD PROCESSING INDUSTRIES*** be pleased to state:

- (a) the steps taken or proposed to be taken to promote the food processing sector in Odisha;
- (b) the locations of Food Processing Parks being set up in the country;
- (c) the number of such parks established in the last five years, State-wise and year-wise;
- (d) the details of approved projects to support small-sized businesses in Odisha during the last five years;
- (e) the number and locations of functional Food Processing Units (FPUs) across the country, particularly in Odisha; and
- (f) whether Government plans to set up more FPUs and has any long-term scheme for rural areas of Odisha, if so, the details thereof?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES
(SHRI RAVNEET SINGH)

(a). In order to promote and ensure overall development in the food processing sector, Ministry of Food Processing Industries (MoFPI) has been incentivizing setting up/expansion of related infrastructure through its Central Sector Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) Scheme, Production Linked Incentive Scheme for Food Processing Industry (PLISFPI) and Centrally Sponsored PM Formalization of Micro Food Processing Enterprises (PMFME) Scheme across the country including Odisha. These schemes are not region or state specific but demand driven. Under sub-schemes of PMKSY, MoFPI provides mostly credit linked financial assistance (capital subsidy) to entrepreneurs with total outlay of Rs.5520 crore for 15th Finance Commission Cycle. MoFPI also provides financial, technical and business support for setting up/ upgradation of micro food processing enterprises under PMFME scheme. The scheme is operational from 2020-21 to 2025-26 with total outlay of Rs.10,000 crores. PLISFPI is, inter alia, intended to support creation of global food manufacturing champions and support Indian brands of food products in international market. The Scheme is operational for a period from 2021-22 to 2026-27 with an outlay of Rs. 10,900 crores.

(b). The details of approved Mega Food Parks under PMKSY since inception is at **Annexure-I**.

(c). State-wise details of approved Mega Food Parks under PMKSY since 2019-20 is at **Annexure-II**.

(d). A total of 1684 micro food processing Enterprises have been approved in state of Odisha under PMFME Scheme.

(e). The number of registered food processing units across the country, including Odisha, as per Annual Survey of Industries 2022-23, is at **Annexure-III**.

(f). MoFPI does not set up food processing units on its own. It is incentivizing establishment of such facilities through its schemes of PMKSY, PMFME and PLIS, which are demand driven in nature and implemented across the country including rural areas of Odisha.
