- (a) whether it is a fact that the aviation sector in the country is moving towards a duopoly where IndiGo commands a 60 per cent market share and Tata Group airlines have a 28 per cent; and
- (b) the steps taken and incentives provided by Government to encourage the entry of new players in country's civil aviation sector?

#### **ANSWER**

(a) and (b): India is one of the fastest growing aviation markets in the world. Market share of Airlines keeps on changing as and when new aircraft are inducted and operationalised. As per the information received by the Directorate General of Civil Aviation (DGCA), the market share of scheduled Airlines in the country is at Annexure.

The National Civil Aviation Policy, 2016 seeks to provide a conducive ecosystem for overall growth of the Indian aviation sector in a harmonised manner that includes growth of all its subsectors viz airlines, airports, MRO, FTO etc. The Policy envisages growth of civil air transport operations creating an environment for existing airlines to grow and new airlines to enter. The Regional Connectivity Scheme-UDAN has further enhanced the potential for new airlines to emerge.
