FUNDING UNDER SMART CITY MISSION

NO. 2282. SHRI ADITYA PRASAD:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details of the utilization of the Central and State assistance sanctioned so far for the 100 Smart Cities selected under the Smart City Mission, city-wise and year-wise;
- (b) whether Government have any plan to select and develop 100 new cities as Smart Cities apart from those 100 Smart Cities which were selected earlier;
- (c) whether the targets under all the schemes for selected Smart City in the country, especially in Ranchi, Jharkhand have been achieved; and
- (d) if not, the reasons for the delay?

ANSWER

**THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS
(SHRI TOKHAN SAHU)**

- (a) Under the Smart Cities Mission (SCM), the Central Government has a total outlay of ₹48,000 crore for the 100 cities. As on 15.11.2024, a total fund amounting to ₹88,177 crore (Central Government share of ₹47,225 crore and State/ Union Territories matching share of ₹40,952 crore) has been released to States/UTs under SCM, out of which ₹82,351 crore (Central Government share of ₹44,626 crore and State/ Union Territories share of ₹37,725 crore) has been utilized. City-wise details of funds released and utilized by Central Government as well State/UT Government is given at Annexure. Year-wise details of utilization of State/UT share is not maintained at Central level.
- (b) At present, there is no proposal under consideration of the Central Government to extend the existing SCM by including additional cities.
- (c) As on 15.11.2024, under the Smart Cities Mission (SCM), work orders have been issued in 8,066 projects amounting to ₹1,64,669 crore, of which 7,352 projects (i.e. 91% of total projects) amounting to ₹1,47,366 crore have been completed, as per the data provided by 100 Smart Cities. Remaining 714 projects amounting to ₹17,303 crore are currently in implementation stage.

Ranchi Smart City Corporation Limited has completed all its 26 projects amounting to ₹1,847 crore under SCM.

- (d) Government of India's policy and strategy for Indian Urban Development follows the provisions as laid down in the Constitution of India. It is pertinent to mention here that 'Land' and 'Colonization' are State subjects. Further, as per the 12th Schedule of Indian Constitution (Article 243W), Urban Planning including Town Planning is the responsibility of Urban Local Bodies/ Urban Development Authorities. However, Government of India views high urbanization as an opportunity towards aspirations of faster economic development. Government of India supplements the efforts of the States through schematic interventions/ advisories.

As apprised by the Smart Cities, the challenges encountered in implementing smart city projects include, *inter alia*, legal issues, delay in obtaining clearances from different departments, land acquisition, construction in hilly areas, challenges in vendor and resource availability in small & medium cities, centralization of decision making in few cities, utilization of full capacity of ICCCs with integration of all municipal departments and agencies, frequent changing and dropping of projects.
