CLUSTER SUPPORTED UNDER MSE-CDP

2332. SHRI ASHOKRAO SHANKARRAO CHAVAN:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:-

- (a) the details of cluster supported under the Micro and Small Enterprises-Cluster Development Programme (MSE-CDP) during each of the last three years, State-wise;
- (b) the criteria for providing financial assistance to cluster under MSE-CDP;
- (c) whether Government has identified new clusters for development under MSE-CDP in current financial year;
- (d) if so, the details of these clusters, including their location and focus industries along with timeline for their development;
- (e) whether Government provides financial or technical assistance to existing clusters for modernization and capacity building under MSE-CDP; and
- (f) if so, amount disbursed for these purpose during each of the last three years?

(a), (e) & (f): Micro and Small Enterprises Cluster Development Programme (MSE-CDP) is implemented for establishment of Common Facility Centers (CFCs) and establishment/up-gradation of Infrastructure Development (ID) projects in industrial estates/areas/flatted factory complexes with an objective to enhance the productivity and competitiveness of Micro and Small Enterprises (MSEs) for their holistic development addressing the common issues of the existing clusters.

The detail of projects supported for development of existing clusters State/UT-wise is *annexed* and the total budget allocation and fund disbursed under the MSE-CDP scheme during last three years (2021-22 to 2023-24) is given below:

(b): As per the criteria laid in the guidelines of the scheme, GoI grants are released for implementation of projects in three installments after final approval, depending upon the implementation plan, progress made, requirements of funds, the utilization of GoI grants released, etc.
