CYBER CRIMES AND DIGITAL FRAUDS

233 SHRI ABDUL WAHAB:

Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that, the number of digital crimes has increased in the last five years;

(b) if so, the number and types of digital cases registered in the last five years;

(c) the details of money that people have lost due to cyber frauds in the last five years;

(d) the number of cases resolved or cracked by Government agencies and money recovered in the last five years; and

(e) the measures taken by Government to make people aware of cyber crimes and phenomenon like Digital arrests?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI BANDI SANJAY KUMAR)

(a) to (e): The National Crime Records Bureau (NCRB) compiles and

publishes the statistical data on crimes in its publication "Crime in India".

The latest published report is for the year 2022. As per the data published

by the NCRB, Crime Head-wise details of cases registered under cyber crimes (involving communication devices as medium/target) during the period from 2018 to 2022 is at the Annexure-I.

As per the data published by the NCRB, State/UT wise details of cases registered, cases charge-sheeted, cases convicted, persons arrested, persons charge-sheeted and persons convicted under fraud for cyber crimes (involving communication devices as medium/target) during the period from 2018 to 2022 are at Annexure-II.

'Police' and 'Public Order' are State subjects as per the Seventh Schedule of the Constitution of India. The States/UTs are primarily responsible for the prevention, detection, investigation and prosecution of crimes including cyber crime through their Law Enforcement Agencies. The Central Government supplements the initiatives of the States/UTs through advisories and financial assistance under various schemes for capacity building of their LEAs, which, inter-alia, include the following:

i. The Ministry of Home Affairs has set up the 'Indian Cyber Crime Coordination Centre' (I4C) as an attached office to deal with all types

of cybercrimes in the country, in a coordinated and comprehensive manner.

- ii. The 'National Cyber Crime Reporting Portal' (https://cybercrime.gov.in) has been launched, as a part of the I4C, to enable public to report incidents pertaining to all types of cyber crimes, with special focus on cyber crimes against women and children. Cyber crime incidents reported on this portal, their conversion into FIRs and subsequent action thereon are handled by the State/UT Law Enforcement Agencies concerned as per the provisions of the law.
- iii. The 'Citizen Financial Cyber Fraud Reporting and Management System', under I4C, has been launched in year 2021 for immediate reporting of financial frauds and to stop siphoning off funds by the fraudsters. So far, financial amount of more than Rs. 3431 Crore has been saved in more than 9.94 lakh complaints. A toll-free Helpline number '1930' has been operationalized to get assistance in lodging online cyber complaints.
- iv. I4C has imparted cyber hygiene training to 7,330 officials of various Ministries/ Departments of Government of India.

- v. I4C has imparted cyber hygiene training to more than 40,151 NCC cadets.
- vi. To spread awareness on cyber crime, the Central Government has taken steps which, inter-alia, include; dissemination of messages through SMS, I4C social media account i.e. X (formerly Twitter) (@CyberDost), Facebook(CyberDostI4C), Instagram (cyberDostI4C), Telegram(cyberdosti4c), Radio campaign, engaged MyGov for publicity in multiple mediums, organizing Cyber Safety and Security Awareness weeks in association with States/UTs, publishing of Handbook for Adolescents/Students, newspaper advertisement on digital arrest scam, announcement in Delhi metros on digital arrest and other modus operandi of cyber criminals, use of social media influencers to create special posts on digital arrest, digital displays on railway stations and airports across, etc.
