### MINERAL EXPLORATION IN THE NORTH-EASTERN REGION

### 2346 SHRI RWNGWRA NARZARY:

Will the Minister of MINES be pleased to state:

(a) whether Government is planning to step up exploration of mineral commodities including oil and Natural gas in the North Eastern States;

(b) the critical mineral commodities explored in the North-Eastern States in the years 2022, 2023, 2024;

(c) the quantum of fund sanctioned, released and spent for mineral exploration in the North-Eastern States, project-wise in the year 2022, 2023, 2024;

(d) if so, the details thereof; and

(e) if not, the reasons therefor?

#### ANSWER

# THE MINISTER OF COAL AND MINES (SHRI G. KISHAN REDDY)

(a): Geological Survey of India (GSI), an attached office of Ministry of Mines, has taken up 29 mineral exploration projects during its current field season programme 2024-25 for various mineral commodities like limestone, graphite, vanadium, coal, rare earth element & rare metal, phosphorite, bauxite, gold, base metal, etc. in different parts of Assam, Arunachal Pradesh, Meghalaya, Manipur & Nagaland, Tripura, Sikkim with an aim to augment mineral resources. Further, to enhance oil and natural gas exploration activities in North Eastern States, Ministry of Petroleum and Natural Gas has awarded 35 blocks under different Open Acreage Licensing Programme (OALP) rounds in Assam Shelf and Assam-Arakan Fold Belt Basin in North Eastern States. A total of 9 wells have been drilled so far during 2024-25.

(b): GSI has taken up 43 critical mineral exploration projects in the North Eastern States of Arunachal Pradesh, Assam, Meghalaya, Nagaland and Tripura in the field seasons 2022-23 2023-24 and 2024-25. The details are given in Annexure.

Further, 7 critical mineral exploration projects have also been taken up by other agencies in North Eastern States during 2021-22 to 2024-25 through funding by National Mineral Exploration Trust. The details are as follows:
