- (b) The aspirational districts were selected through a transparent process on the basis of published data. List of data sets and the weight attached to them for selection of these districts is attached in Annexure I.
- (c) and (d) Under the Aspirational Districts Programme, districts undertake various developmental projects to address critical gaps using the performance grants they win through the programme's delta ranking method. The total funds sanctioned and utilised for the development of Aspirational District Nuh under the ADP is Rs. 18.2 crores. The details of the projects undertaken by Nuh is attached as Annexure II.
