DIGITIZATION OF PANCHAYATS IN ODISHA

247. SHRI DEBASHISH SAMANTARAY:

Will the Minister of PANCHAYATI RAJ be pleased to State:

- (a) the number of Panchayats in Odisha that have been digitized under the e-Panchayat Mission Mode Project;
- (b) whether there is a timeline for digitizing the remaining Panchayats in Odisha; and
- (c) the improvements expected in governance and public service delivery through the digitization of Panchayats?

ANSWER

(a) to (c) Under Digital India Programme, Ministry is implementing e-Panchayat Mission Mode Project (MMP) with the aim to making Panchayats, more transparent, accountable, and effective as local self-governments. Building on the achievements in the past, the Ministry launched eGramSwaraj, a work-based comprehensive application for Panchayats under the e-Panchayat MMP on 24th April 2020. This application encompasses all aspects of Panchayat functioning viz. planning, budgeting, accounting, monitoring, asset management etc., on a single digital platform including online payments. Currently, 2.54 lakh Gram Panchayats (GPs) across India have prepared and uploaded their Gram Panchayat Development Plans (GPDPs) for the financial year 2024-25. Additionally, 2.36 lakh GPs have conducted online transactions under the 15th Finance Commission grants. In Odisha, 6,787 out of 6,794 GPs have prepared their GPDPs for FY 2024-25. In addition, 6,786 out of 6,794 GPs have adopted the eGramSwaraj-PFMS interface so far.

The digitization of Panchayats is expected to significantly enhance governance and public service delivery in the following ways:

Transparency and Accountability: Comprehensive digital platforms like eGramSwaraj provide real-time access to data on planning, budgeting, and accounting, enabling citizens to monitor the functioning of Panchayats.

Financial Management: Integration with platforms such as PFMS, AuditOnline and Government e-MarketPlace (GeM) ensures better financial transparency, audit readiness, and

streamlined procurement processes.

Improved Asset Management: Tools like mActionSoft enable geo-tagging of assets at all stages of development, providing a robust repository of information on infrastructure created under Panchayat initiatives.

Efficiency in Service Delivery: Digitized processes reduce delays and errors in fund transfers, improve planning for development works and ensure proper utilization of grants.

Strengthened Governance: With the availability of audited accounts in the public domain, decision-making processes at the grassroots level are expected to improve, fostering citizen participation in local governance.

The Ministry is committed to achieving 100% digitization of Panchayats across the country, including Odisha. Efforts are going on to ensure that all remaining Panchayats are brought under the fold of the e-Panchayat MMP.
