PM Shri Scheme in Goa

2585 Shri Sadanand Mhalu Shet Tanavade:

Will the Minister of *Education* be pleased to state:

- (a) the main objectives and distinctive features of the PM Schools for Rising India (PM Shri) Scheme;
- (b) the manner in which the scheme contribute to effectively implementing the National Education Policy, 2020;
- (c) progress that has been achieved under this scheme so far; and
- (d) whether the Ministry provide specific details on the status of schools in Goa that have been identified or developed under the PM Shri scheme along with the funds allocated for this purpose?

(a) to (c): PM SHRI schools are set up by strengthening the existing schools from amongst schools managed by Central Government/State/UT Government/local bodies. These schools are to showcase all the initiatives of National Education Policy 2020 and emerge as exemplar schools over a period of time, and also offer leadership to other schools in the neighbourhood. They provide leadership in their respective regions in providing high-quality education in an equitable, inclusive and joyful school environment that takes care of the diverse background, multilingual needs, and different academic abilities of children and makes them active participants in their own learning process as per the vision of NEP 2020.

The major features in the PM SHRI Scheme which are aligned to showcase NEP 2020:

1. Quality and Innovation (Learning Enhancement Programme, Holistic Progress Card, Innovative Pedagogies, Bagless days, Internships with Local artisans, Capacity building etc.)
2. Beneficiary oriented Entitlements under Right to Education (RTE) Act.
3. Annual School Grants (Composite School grants, Library grant, Sports grant)
4. Early Childhood Care and Education including Balvatika and Foundational Literacy and Numeracy
5. Equity and Inclusion including provision of safe and appropriate infrastructure for girls and children with special needs (CwSN).
6. Encouraging flexibility in choice of subjects offered to students.
7. Encouraging mother tongue as medium of instruction using technological interventions to help bridge language barriers between teachers and students.
8. ICT, smart classrooms and digital libraries for using digital pedagogy.
9. Strengthening of existing infrastructure

10. Vocational interventions & Enhancing internship/entrepreneurship opportunities especially with local industry. Mapping of skills with developmental projects/nearby industry and develop courses/curriculum accordingly.

A total of 12,084 schools have been selected from 32 States/UTs along with KVS & NVS up to 4th phase of selection of PM SHRI Schools through the transparent challenge method out of which 1329 schools are Primary, 3340 schools are Elementary, 2907 schools are secondary and 4508 schools are senior secondary.

A central share of Rs. 1,216.71 crore was released to 6,207 PM SHRI schools selected in the first phase during FY 2023-24 for implementation of the scheme. Further, a total of Rs. 7,107.56 cr (Centre + State) has been approved for 12,084 PM SHRI schools selected up to 4th phase of selection in 32 States/UTs and KVS & NVS by the Project Approval Board (PAB) out of which Rs. 5,097.05 cr has been approved as central share for FY 2024-25. So far, ₹1,392.66 crore has been released in FY 2024-25 to States/UTs, KVS, and NVS for the scheme's implementation.

(d): Under the PM SHRI scheme, a total of 25 schools have been selected from the state of Goa, including 6 primary schools, 1 elementary school and 18 secondary schools. The details of PM SHRI schools selected in Goa is attached as **Annexure-I**.

A total of Rs. 6.19 cr (Rs. 3.71 cr central share + Rs. 2.48 cr state share) was approved for 12 PM SHRI schools from the state of Goa by Project Approval Board (PAB) in the FY 2023-24 out of which Rs. 3.25 cr was released as central share in FY 2023-24. In FY 2024-25, a total of Rs. 15.24 cr (Rs. 9.14 cr central share + Rs. 6.1 cr state share) has been approved for 25 PM SHRI schools from the State of Goa by Project Approval Board (PAB) out of which Rs. 1.54 cr has been released as central share so far in FY 2024-25 for implementation of PM SHRI Scheme.
