Quality of education at Primary Level

2612. Shri Neeraj Shekhar:

Will the Minister of Education be pleased to state:

- (a) the details of schemes being run by Government to improve quality of education at primary level along with augmentation of infrastructure in primary schools in the country, scheme-wise;
- (b) the details of fund allocated, released and utilised during 2023-24 and 2024-25 till date, schemewise and State-wise; and
- (c) the details of percentage of primary schools covered under internet infrastructure/facility in the country as on date, State-wise?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SHRI JAYANT CHAUDHARY)

(a): The details of schemes being run by Government to improve quality of education at primary level are as follows-

Samagra Shiksha

The Department of School Education and Literacy (DoSE&L) is implementing an integrated centrally sponsored scheme for School Education- Samagra Shiksha since 2018-19. It aims to ensure that all children have access to quality education with an equitable and inclusive classroom environment which should take care of their diverse background, multilingual needs, difference academic abilities and make them active participants in the learning process. Under the Scheme, support is provided to States and UTs for strengthening of existing Government schools and for creation and augmentation of infrastructure facilities, based on the gaps determined from Unified District Information System for Education (UDISE+) and proposals received from respective States/ Union Territories. Financial assistance is provided to all the States and UTs for undertaking various activities for Universalization of School Education including opening/strengthening of new schools upto senior secondary level, construction of school buildings & additional classrooms, setting up, up-gradation and running of Kasturba Gandhi Balika Vidyalayas, setting up and running of Netaji Subhash Chandra Bose Avasiya Vidyalayas, setting up of hostels under PM JANMAN for unserved PVTG habitations covered, setting up of hostels under DAJGUA scheme for unserved ST provision of free uniforms, free text books to the eligible students at habitations covered, elementary level, transport allowance and undertaking enrolment & retention drives.

Pradhan Mantri Poshan Shakti Nirman (PM POSHAN)

Pradhan Mantri Poshan Shakti Nirman (PM POSHAN) Scheme is one of the foremost rights based Centrally Sponsored Schemes implemented in partnership with States and UTs providing one hot cooked and nutritious meal to the eligible children. This Scheme is implemented across the country covers 11.70 crore children of Balvatika (just before class I) and Classes I-VIII studying in 10.24 lakh Government and Government-Aided Schools. The objectives of the Scheme are to address two of the pressing problems for majority of children in India, viz. hunger and education by:

- i. Improving the nutritional status of children studying in Bal Vatika (just before class I) and classes I–VIII in Government and Government-Aided Schools without any discrimination.
- ii. Encouraging poor children, belonging to disadvantaged sections, to attend school more regularly and help them concentrate on classroom activities.
- iii. Providing nutritional support to children of elementary stage in drought / disaster affected areas during summer vacation and disaster times.

The overall responsibility for smooth functioning of the scheme including providing hot cooked and nutritious meal to the eligible children lies with the State Governments and Union Territory Administrations. The Government of India has issued detailed guidelines on quality, safety and hygiene to ensure serving of good quality meal under the Scheme to all the States/UTs. These guidelines are available on official website https://pmposhan.education.gov.in

Pradhan Mantri Schools for Rising India (PMSHRI)

PM SHRI scheme aims to establish over 14,500 exemplar schools by strengthening existing schools managed by Central/State/UT Governments and local bodies, including KVS and NVS. These schools are to showcase all the initiatives of the National Education Policy (NEP) 2020 and emerge as exemplar schools. A total of 12,084 schools have been selected under the PM SHRI scheme, including 1,329 primary schools, 3,340 elementary schools, 2,921 secondary schools, and 4,494 senior secondary schools.

The scheme has various provisions to improve the quality of education at the primary level, including non-recurring grants for BaLA features, child-friendly furniture, and outdoor play materials. It also includes recurring grants for teaching-learning materials (TLM) such as worksheets/workbooks, toys, puzzles, board games, storybooks, and art and craft materials. Additionally, the usage of Jaadui Pitara is promoted to encourage play-based learning and creativity in students.

The scheme emphasizes experiential learning through art, sports, and toy-based pedagogies. It includes provisions for competency-based assessments and the implementation of Holistic Progress Cards (HPC) to track student progress across cognitive, affective, and psychomotor domains. The scheme also promotes the implementation of three-month school readiness module for Grade 1 students, focusing on play-based activities and regular assessments.

There is a provision of Teacher Resource Materials such as manuals and activity handbooks for teachers to align their innovative pedagogies with learning outcomes and grade level competencies. All the above initiatives aim to create an inclusive, high-quality, and stimulating learning environment for all students at the primary level under the PM SHRI scheme.
