SKILL DEVELOPMENT COURSE ON ENTREPRENEURSHIP AND BUSINESS MANAGEMENT

2669. SHRI SANDEEP KUMAR PATHAK:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) whether there is any specific course or training program on entrepreneurship and business management under Pradhan Mantri Kaushal Vikas Yojana (PMKVY), if so, details of its components;
- (b) the number of youth skilled in such course in the last five years, the number of youths having started business/start-up after this course, State-wise/UT-wise;
- (c) whether there is any provision for a start-up fund after such a course, if so, the details thereof; and
- (d) the number of youths received such a startp fund each year in the last five years, the minimum, maximum and average funds provided to youth each year, State-wise/UT-wise?

ANSWER

THE MINISTER OF STATE (INDEPENDENT CHARGE) IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(SHRI JAYANT CHAUDHARY)

(a) Ministry of Skill Development and Entrepreneurship (MSDE) is implementing its flagship Scheme Pradhan Mantri Kaushal Vikas Yojana (PMKVY) since 2015. Under PMKVY, skill training is imparted through Short Term Training (STT) and Re-skilling and Up-skilling through Recognition of Prior Learning (RPL) to youth across the country.

Under PMKVY 4.0, specific modules of Employability Skills have been included in all the courses that focus on entrepreneurship and business management. These modules emphasize on equipping candidates with financial and legal literacy skills such as entrepreneurial mindset, market analysis, business planning, marketing strategies, and basic legal compliance for small businesses. These components are delivered as part of the 'Employability Skills' curriculum embedded in PMKVY 4.0 training programs.

(b) Number of youth trained / oriented under PMKVY 4.0 in the last five years and in the current Financial Year is as under:

Placements/Self-employment were tracked in the Short-Term Training (STT) component in the first three versions of the PMKVY Scheme i.e. PMKVY 1.0, PMKVY 2.0 and PMKVY 3.0 implemented from FY 2015-16 to FY 2021-22. Under PMKVY 4.0 which is currently under implementation from FY 2022-23 onwards, the focus is to empower our trained candidates to choose their varied career path and they are suitably oriented for the same.

State-wise/UT-wise details of youths reported self-employed in the last five years under PMKVY 4.0 is given at *Annexure I*.

(c)and(d) There is no such provision under PMKVY 4.0 for a start-up fund after completing the course.
