**Will the Minister of CULTURE be pleased to state:**

- (a) the details of the budget sanctioned and allocated by the Central Government to Himachal Pradesh, item-wise, under the scheme administered by the Ministry in the last two years;
- (b) whether the State of Himachal Pradesh has submitted utilization certificate for the expenditure incurred under all the schemes, if so, details thereof, if not, the reasons therefor; and
- (c) whether Government monitors the accounts of budget allocated for various items provided by Ministry, if so, the details thereof, if not, the reasons therefor?

- (a) All the schemes of the Ministry of Culture are Central Sector Schemes, implemented directly through the central Government through its organizations and funds are not sanctioned directly to States/UT Governments. However the details of the Financial Assistance provided to different institutions/NGOs/scholars of the State of Himachal Pradesh by the Ministry is given at Annexure A.
- (b) Yes, the institutions/NGOs/scholars submit Utilization Certificates to the Program/Scheme Divisions from where grants are received by them.
- (c) Yes, Ministry of Culture, monitors the accounts of budget allocated for various items provided by Ministry through regular meetings.

### 1. National Mission on Libraries

Raja Rammohun Roy Library Foundation (RRRLF), Kolkata, an autonomous organization of the Ministry provides financial assistance under its Matching and Non-Matching schemes for development of public libraries on the basis of applications recommended by the respective State Library Authorities.
