### TRAINING UNDER PMKVY IN UTTRAKHAND

#### 277. DR. KALPANA SAINI:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:-

(a) the number of people who have been trained under various Pradhan Mantri Kaushal Vikas Yojana (PMKVY) during the last three years in Uttarakhand, district-wise details thereof;

(b) the status of providing employment to skilled workers in Uttarakhand and the number of new jobs that have been created during the last three years, the district-wise details thereof; and

(c) whether any step has been taken to motivate new entrepreneurs in Uttarakhand, especially in Haridwar region, if so, the details of the steps taken?

#### ANSWER

# THE MINISTER OF STATE (INDEPENDENT CHARGE) IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

#### (SHRI JAYANT CHAUDHARY)

(a) Under PMKVY, district wise details of candidates trained in State of Uttarakhand during last three financial years from FY 2021-22 to FY 2023-24 is given at Annexure.

(b) Under the PMKVY scheme, placements were tracked in the Short-Term Training (STT) component in the first three versions of the Scheme which is PMKVY 1.0, PMKVY 2.0 and PMKVY 3.0 implemented from FY 2015-16 to FY 2021-22. Under PMKVY 4.0, the focus was to empower our trained candidates to choose their varied career path and they are suitably oriented for the same. Further various IT tools like skill India Digital Hub (SIDH) also gives this opportunity. District wise details of candidates reported placed under first three versions of PMKVY during last three financial years from FY 2021-22 to FY 2023-24 in State of Uttarakhand is given at Annexure.

(c) Ministry of Skill Development and Entrepreneurship (MSDE) through National Institute for Entrepreneurship and Small Business Development (NIESBUD) has been working for the empowerment, upliftment and development of entrepreneurs across the country including the State of Uttarakhand. The details of the initiatives taken are as under

(i) NIESBUD has implemented a project under Skill Acquisition and Knowledge Awareness of Livelihood Promotion (SANKALP) Programme of MSDE for strengthening the entrepreneurship ecosystem across different sections of the society including marginalized population. Under this project, 3066 candidates have been trained in State of Uttarakhand (ii) Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM-JANMAN): PM-JANMAN, a Scheme of Ministry of Tribal Affairs (MoTA) aims at targeted development of 75 Particularly Vulnerable Tribal Groups (PVTGs) by offering entrepreneurship and value-added skills training residing in 18 States including 1 Union Territory. Under this project, 790 candidates have been trained in State of Uttarakhand. This initiative supports Particularly Vulnerable Tribal Groups (PVTGs)

(iii) STRIVE Project – Under the Skill Strengthening for Industrial Value Enhancement (STRIVE) project of MSDE, NIESBUD is conducting Entrepreneurship Awareness, Entrepreneurship Development Programme, Mentoring, and Handholding of trainees (and future trainers) in Industrial Training Institute (ITIs) and National Skill Training Institute (NSTIs). Under this project, 1809 candidates have been trained in State of Uttarakhand.

(iv.) NIESBUD implemented a project for creating entrepreneurial climate through Training of Trainers and Entrepreneurship Development Programme in Jan Shikshan Sansthan (JSS). Under this project, 311 candidates have been trained in State of Uttarakhand.

(v) Entrepreneurship Development in Holy Cities: This pilot project in Haridwar focuses on reviving existing livelihoods, scaling up enterprises, and mentoring potential entrepreneurs. Under this project, 1431 candidates have been trained especially in Haridwar, Uttarakhand.
