IMPLEMENTATION OF PDMC SCHEME

2899. SHRI C. VE. SHANMUGAM:

Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

- (a) whether Government is implementing Per Drop More Crop (PDMC) scheme in the country, especially in Tamil Nadu;
- (b) if so, the details of number of farmers and the details of farmland covered under this scheme in the country, especially in Tamil Nadu;
- (c) the details of the targets set and achieved under this scheme during the last five years, year-wise, State-wise; and
- (d) the further measures proposed to be taken by Government in this regard?

ANSWER

THE MINISTER OF STATE FOR AGRICULTURE AND FARMERS WELFARE
(SHRI RAMNATH THAKUR)

- (a): Yes Sir. Government is implementing Per Drop More Crop (PDMC) scheme in the country including Tamil Nadu since 2015-16.
- (b): From 2015-16 till date, an area of 94.36 lakh ha has been covered under micro irrigation in the country through PDMC scheme benefitting 86.14 lakh farmers. In the State of Tamil Nadu, an area of 11.86 lakh ha has been covered during this period benefitting 11.36 lakh farmers.
- (c) & (d): PDMC is a Centrally Sponsored Scheme implemented under Pradhan Mantri Rashtriya Krishi Vikas Yojana (PM-RKVY). All States/UTs prepare their own Annual Action Plan for taking up micro-irrigation activities under the scheme as per their requirement which is approved by the State Level Sanctioning Committee. Accordingly, Central Government supports the States/UTs to implement their plan. Statewise and yearwise details of area covered under Micro Irrigation through the scheme during the last five years is annexed.
