Scheme for digitization of land records

3009. Shri Anil Kumar Yadav Mandadi:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether Government has formulated any comprehensive scheme to digitize all the land records across the country;
- **(b)** if so, the details of number of village across the country;
- (c) whether Government is promoting registration process in all the sub-registrar offices across the country in a digital format only; and
- (d) if so, the details thereof?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (Dr. CHANDRA SEKHAR PEMMASANI)

(a) & (b) Yes Sir. Government of India has been implementing a comprehensive programme for digitization and computerization of land records and registration processes in the country by the name of Digital India Land Records Modernization Programme (DILRMP) with 100% financial assistance from Central Government since 2016-17. The DILRMP has been extended for a period of five years from 01.04.2021 to 31.03.2026. As of now, 98.50% digitization of the existing land records (Record of Rights) has been completed in the villages of the country. Some of the areas of NE States do not have land records like other States due to community ownership issue and UT of Ladakh has started digitization in last couple of years. State wise status of computerization of land records (Record of Rights) is enclosed at Annexure-1.

(c) & (d) Yes Sir. Computerization of Sub Registrar Offices (SROs) has been completed 95.73% across country. State wise status of computerization of SROs is enclosed at Annexure-2. The objective in respect of registration system is now to deploy an end-to-end completely online and paperless system in the States and UTs. As per provisions of Guidelines on the 'Scheme for Special Assistance to States for Capital Investment 2024-25' issued by the Government of India, Ministry of Finance, Department of Expenditure on 09.08.2024, the States with completely online and paperless registration system shall be provided financial incentive. In this regard, to provide technical support to States/UTs, the National Generic Document Registration System (NGDRS) or e-Registration application developed by the Department of Land Resources has been upgraded as paperless registration software.
