FUNDS ALLOCATED UNDER DAY-NRLM

Will the Minister of Rural Development be pleased to state:

- (a) the details of the amount allocated and released under Deen Dayal Antyodaya Yojana National Rural Livelihood Mission (DAY-NRLM) during the last three years, State-wise;
- (b) the targets set and achievements made so far under the Mission;
- (c) whether Government has taken steps to improve the livelihood of citizens in rural areas under the National Rural Livelihood Mission (NRLM); and
- (d) if so, the details thereof?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT
(DR. CHANDRA SEKHAR PEMMASANI)

(a): The State/UT-wise details of the amount allocated and released under Deen Dayal Antyodaya Yojana - National Rural Livelihoods Mission (DAY-NRLM) during the last three years are given at **Annexure**.

(b): DAY-NRLM aims to reach 10 crore women from rural poor households by the financial year 2023-24. The target was achieved during the year 2024 with mobilization of 10.05 crores women into 90.87 lakh Self Help Groups (SHGs), so far, across 34 States and UTs.

(c) & (d): Government has taken several steps under DAY-NRLM to improve the livelihood of SHG members in rural areas. The Mission is being implemented in 7138 blocks in 742 districts across 28 States and 6 UTs. DAY-NRLM provides funds to create a resource in perpetuity for the community institutions to strengthen their institutional and financial management capacity and build their track record to attract mainstream Bank finance. These include Revolving Fund of Rs. 20,000 to Rs. 30,000 per SHG and Community Investment Fund up-to Rs. 2.50 lakh per SHG. The total amount of Capitalisation Support (Revolving Fund and Community Investment Fund) provided is Rs. 48,290 crores. In order to reduce the effective cost of Bank credit to women SHGs, DAY-NRLM provides interest subvention to SHGs on loans from Banks. The total Bank loans disbursed, are Rs. 9.71 lakh crore, till November, 2024.

Further, the Government has taken a number of steps to financially support SHGs and women entrepreneurs under the DAY-NRLM through Start-up Village Entrepreneurship Programme (SVEP), Aajeevika Grameen Express Yojana (AGEY), Mahila Kisan Sashaktikaran Pariyojana (MKSP), Women Enterprise Acceleration Fund (WEAF). DAY-NRLM has also established convergence with various Central Ministries' Schemes, e.g., Namo Drone Didi scheme, Paramparagat Krishi Vikas Yojana, Pradhan Mantri Formalization of Micro Enterprises (PMFME), to support SHG Members in rural areas.
