**CULTURAL ORGANISATIONS GETTING FUNDS FROM THE CENTRAL
GOVERNMENT**

349: SHRI SANDOSH KUMAR P:

Will the Minister of CULTURE be pleased to state:

- (a) the list of cultural organizations getting grants from the Central Government for the last three years, State-wise;
- (b) the criteria for selecting organizations for grants; and
- (c) the list of funds allotted for the cultural organisations for the last three years, State-wise?

MINISTER OF CULTURE AND TOURISM
(SHRI GAJENDRA SINGH SHEKHAWAT)

(a) to (c): Ministry of Culture administers various schemes/ sub-schemes under umbrella scheme 'Kala Sanskriti Vikas Yojana (KSVY)' under which financial assistance is provided to cultural organization(s)/ Institution(s), individuals etc. for promotion of Art and Culture.

For the various schemes of KSVY, the applications/ proposals are invited from eligible cultural organizations/individuals by the designated Nodal agencies/Ministry each year. Application(s)/ proposal(s) found to be complete in the preliminary scrutiny are placed before the duly constituted Expert Committee/Steering Committee under each scheme/sub-scheme for its evaluations and recommendations on case-to-case basis as per the criteria such as cultural profile/ activities of the organizations during previous years, registration on NGO Darpan, etc. and other requisite documents as laid in the guidelines of each scheme.

Ministry of Culture also operates Museum Grant Scheme under which financial assistance is provided for setting up new museum/development of existing museum by Central/State Governments and Public Sector Undertakings, Societies, Autonomous Bodies, Local Bodies and Trust registered under the Societies Registration Act, 1860 at the regional, state and district level to preserve the cultural heritage. The proposal is submitted for consideration of the Expert Committee constituted under Museum Grant Scheme.

The state-wise details of number of cultural organizations and fund released to various cultural organizations under schemes/ sub-schemes of KSVY and Museum Grant Scheme during the last three years is given at **Annexure**.
