**EXPORT PERFORMANCE AND GOVERNMENT SUPPORT TO ODISHA TO
PROMOTE EXPORTS**

544. SHRI MANAS RANJAN MANGARAJ:

Will the Minister of COMMERCE & INDUSTRY be pleased to state:

- (a) the details of export performance of Odisha during the last three years, including the value of key exported commodities such as minerals, seafood and handicrafts;
- (b) whether Government has taken initiatives to promote exports from Odisha, particularly in sectors like agriculture, textiles, and Micro Small and Medium Enterprises (MSMEs);
- (c) if so, the details of support provided by Government to enhance Odisha's participation in the international market, including financial assistance, marketing and infrastructure development; and
- (d) if not, the reasons therefor?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY
(SHRI JITIN PRASADA)

(a) The details of export of Odisha for the last 3 years including the value of key exported commodities such as minerals, seafood and handicrafts are given at Annexure.

(b) to (d) The major initiatives taken by the government for promotion of exports in the country, including the State of Odisha are as below:

(i) Agricultural & Processed Food Products Export Development Authority (APEDA) has Central Sector specific scheme for Financial Assistance to facilitate the export of agri-products by providing assistance to exporters Pan India for augmenting export related infrastructure, participating in Buyer Seller Meets, etc.

(ii) Ministry of Textiles is implementing National Handicraft Development Programme (NHDP) which envisages need based interventions for the development and promotion of Handicrafts. Under Marketing Support and Services (MSS) component, access to

international and domestic markets across the country, including Odisha is provided to the Handicrafts sector.

(iii) The Ministry of Micro, Small and Medium Enterprises (MSMEs) have developed a dedicated support system for export promotion in the MSME Sector by Establishing 65 Export Facilitation Centres (EFCs) in it's field organizations namely MSME – Development and Facilitation Offices, MSME – Technology Centres and MSME Testing Centres. In Odisha 02 EFCs have been established viz., MSME – DFO, Cuttack and Central Tool Room & Training Centre (CTTC), Bhubaneswar.

(iv) The Marine Products Export Development Authority (MPEDA) provides assistance for upgrading the infrastructure facilities for value addition, establishing testing laboratories, participating in international trade fairs, and providing technical assistance for aquaculture production meant for exports etc on PAN India basis including Odisha.

(v) Department of Commerce through Directorate General of Foreign Trade (DGFT) has taken measures to promote exports from all districts of Odisha under the Districts as Export Hubs (DEH) Initiative. DGFT, in consultation with stakeholders, has identified products and services including agriculture product and textiles with export potential in all the districts of Odisha. Further, Institutional Mechanism in the forms of District Export Promotion Committee (DEPC) at districts level and State Export Promotion Committee (SEPC) have been set up in the State. District Export Action Plans have also been prepared for all the districts of Odisha.

(vi) The Department of Commerce, Government of India is implementing a scheme namely 'Trade Infrastructure for Export Scheme (TIES)', a Central Sector Scheme, w.e.f. FY 2017-18 with the objective of assisting Central and State Government agencies in the creation of appropriate infrastructure for growth of exports. Under the scheme, financial assistance in the form of grant-in-aid is provided to Central/State Government owned agencies for setting up or up-grading export infrastructure.
