CONSTRUCTION OF ROADS UNDER PMGSY IN UTTAR PRADESH

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the details of the roads constructed in various states including Uttar Pradesh under Pradhan MantriGraminSadakYojana (PMGSY) along with the progress in road construction;
- (b) the details of roads sanctioned in Shahjahanpur, Uttar Pradesh during the current financial year;
- (c) total expenditure by Government on PMGSY during the last three years; and
- (d) the role of rural connectivity to enhance overall efficiency of people and strengthening the rural economy, the details thereof?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI KAMLESH PASWAN)

(a): Details of the road works sanctioned and completed in various States including Uttar Pradesh under Pradhan MantriGraminSadakYojana (PMGSY) are given in Annexure-I. Road-wise progress of the work may be seen at https://omms.nic.in>proposals>State-wise List of Roads.

(b): A total of 1,476 Km of roadworks have been sanctioned under PMGSY in Shahjahanpur District of Uttar Pradesh since inception and 1,426 Km completed (as of 25.11.24). The timeline for completion of these works is March, 2025. No work has been sanctioned in the current financial year to Shahjahanpur District.

(c): A total of Rs. 46,009.57 Crore has been released as central fund under PMGSY during the last three years and Rs. 72,308.28 Crore expenditure incurred (including State share) during this period.

(d): Since inception till 23.11.2024, a total of 768,733 Km road length has been completed under the programme at a cost of Rs.329,064.51Crore in the country. More than 99.6% of the sanctioned habitations under PMGSY have been connected through all-weather road. Various impact evaluation studies have mentioned that the scheme has changed the landscape of rural India and brought about huge socio-economic change in the lives of the rural people. Some of the findings are as under:

(i) Impact Evaluation of Pradhan Mantri Gram SadakYojana, conducted by the World Bank in 2018 :

- The crops taken to the markets for sale from PMGSY roads increased by 8%.
- Farmers selling food grains traveled 7.2 to 9.8 Km farther for higher prices of crops
- The rate of primary employment in the non-farm sector increased by about 13%
- The share of people with primary employment outside their habitation increased by 8%
- Share of babies delivered at home decreased by 30% in connected habitations

(ii) NITI Aayog also evaluated Centrally Sponsored Schemes in the Rural Development Sector, including Pradhan Mantri Gram SadakYojana in 2020, and its findings are as under:

- The scheme is well aligned with India's international goals. It is seen to contribute to SDGs (Sustainable Development Goals) 2 & 9 as it address the issues of poverty, hunger, and infrastructure for growth.
- Roads constructed under PMGSY have been observed to create positive impacts at both the household and the community level.
- The roads have been observed to increase access to market and livelihood opportunities, health and education facilities.
- PMGSY is noted to build the foundations for long-lasting poverty reduction in rural India. Improved rural connectivity provides a long-term and sustained boost in the living standards of rural populations as it allows households to accumulate wealth and human capital.
- Due to the PMGSY roads, rural communities now have better access to markets, healthcare, education, and essential services. The connectivity has boosted agricultural production, marketing, and overall economic activity in rural areas. Easier access to markets and services has empowered women by creating income-generating opportunities and facilitating their participation in the workforce.
