**STATUS OF SMART CITIES PROJECTS IN TAMIL NADU**

**71. DR. KANIMOZHI NVN SOMU:**

**Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:**

- (a) whether Government has provided funds for the Smart Cities Projects in Tamil Nadu;
- (b) if so, the details of the funds allocated till date since its inception;
- (c) the current status of Smart Cities Projects implemented in Tamil Nadu;
- (d) whether Government plans to extend and initiate more Smart Cities Projects in the country including Tamil Nadu; and
- (e) if so, the details thereof and if not, the reasons therefor?

**ANSWER**

(SHRI TOKHAN SAHU)**

- (a) & (b) Yes, the Central Government has released 100% of the eligible Central assistance to the 11 cities of Tamil Nadu, selected under the Smart Cities Mission (SCM). As on 15.11.2024, the 11 cities have received a total of ₹10,879 crore, which includes both the Central assistance and the State matching share. 94% of the total released funds amounting to ₹10,490 crore have been utilized. The city-wise funds details are given at Annexure.
- (c) As per the data provided by the 11 Smart Cities of Tamil Nadu, a total of 708 projects amounting to ₹17,470 crore (i.e. 97% of the total 733 projects) have been completed and the remaining 25 projects amounting to ₹514 crore are at implementation stage.
- (d) & (e) At present, there is no proposal under consideration of the Central Government to extend the existing SCM by including additional cities. All cities are focusing on the completion of ongoing projects till 31<sup>st</sup> March, 2025.
