### PROGRESS AND IMPACT OF PM VISHWAKARMA YOJANA

735. DR. KALPANA SAINI: DR. DINESH SHARMA:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the progress and impact of PM Vishwakarma Yojana since its launch;
- (b) the number of artisans successfully registered under PM Vishwakarma Yojana along with the total number of applications submitted, the details thereof, State-wise;
- (c) the number of training programmes conducted and the expected outcomes from the participants in terms of skill enhancement; and
- (d) the total amount of loan assistance disbursed to artisans and the number of people who have availed this financial assistance?

#### **ANSWER**

# MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SUSHRI SHOBHA KARANDLAJE)

- (a) & (b): PM Vishwakarma Scheme was launched by the Hon'ble Prime Minister on 17.09.2023 to provide end-to-end support to artisans and craftspeople of 18 trades who work with their hands and tools. Under the Scheme, as of 26.11.2024, more than 2.60 crore applications have been received and 24.90 lakh applicants have been successfully registered under the Scheme. The State/UT-wise details of applications received and successful registrations under the Scheme are at **Annexure**.
- (c): Under the Scheme, as of 26.11.2024, 12.40 lakh beneficiaries have successfully completed their skill training. During skill upgradation, beneficiaries' skills are enhanced, and they are introduced to modern tools, best practices, and innovative designs. They also receive training in digital, financial, and soft skills, along with marketing and entrepreneurial knowledge.
- (d): Under the Scheme, as of 26.11.2024, loans amounting to Rs.1,190.29 crore have been disbursed to 1.49 lakh beneficiaries under the Scheme.
