PROMOTING DIVYANGJAN ENTREPRENEURSHIP THROUGH MSME SCHEMES

740. SHRI DHAIRYASHIL MOHAN PATIL:

Will the MINISTER OF MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the details of programmes and schemes of the Ministry for Divyangjan –owned and Divyangjan –centric enterprises across the country;
- (b) the number of beneficiaries under the above programmes and schemes in each State and Union Territory, particularly in the State of Maharashtra, programme/scheme-wise;
- (c) the criteria for selection of Divyangjan enterprises for the said schemes and programmes; and
- (d) the number of Divyangjan entrepreneurs registered in MSME over the last five years, along with specific measures taken to promote Divyangjan entrepreneurship in the MSME sector?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES

(a) to (d): The Ministry of MSME, through its various schemes, programmers and policy initiatives, encourages micro, small and medium enterprises (MSMEs), including those owned by Divyangjan across the country, including in the state of Maharashtra. The number of Divyangjan owned enterprises, registered on Udyam, since inception of Udyam Portal on 1.7.2020, is given at Annexure-I.

There is a separate provision for the Divyangjan owned enterprises in the schemes of Ministry of MSME such as:

- i. Under PMEGP, for beneficiaries belonging to Special Categories such as, Physically Handicapped, the Margin Money subsidy is 35% in rural areas and 25% in urban areas. The maximum cost of project is Rs. 50 lakhs in the manufacturing sector and Rs. 20 lakhs in the service sector. Also, own contribution of beneficiaries under Special Category including women is 5% and 10% for General Category beneficiaries.
- ii. As per the existing guidelines of National Award Scheme of Ministry of MSME, there is a provision of 2 National Awards to Entrepreneurs belonging to ‘Divyang’ Category with cash prize of Rs. 3 Lakhs, each along with Trophy and Certificate.
- iii. Under the Procurement and Marketing Support Scheme, 100% subsidy is provided on built space rent paid by units owned by Physically Handicapped Persons on the minimum stall size of the event for Micro and Small Enterprises in domestic trade fairs.
- iv. The Entrepreneurship and Skill Development Programme (ESDP) Scheme with the objective to motivate young persons (Men and Women), representing different sections of the society including SC/ST, women, physically handicapped, Ex-servicemen and BPL persons to consider self-employment or entrepreneurship as one of the career options. The ultimate objective is to promote new enterprises, build capacity of existing MSMEs and inculcate entrepreneurial culture in the country.

The number of Divyangjan beneficiaries under above major schemes are given at Annexure-II, III and IV.
