# RAJYA SABHA UNSTARRED QUESTION NO. 810 ANSWERED ON 03/12/2024

#### "Cultivation of medicinal plants"

#### 810. Shri C. Ve. Shanmugam:

Will the Minister of *Ayush* be pleased to state:

- (a) whether Government is taking steps to promote cultivation of medicinal plants and herbs in different States of the country and especially in Tamil Nadu, where most of the population believes in AYUSH treatment;
- (b) if so, the details thereof and if not, the reasons therefor;
- (c) whether Government has taken any steps to promote cultivation of medicinal plants and processing infrastructure in the State of Tamil Nadu; and
- (d) if so, the details thereof and if not, the reasons therefor?

#### **ANSWER**

## THE MINISTER OF STATE (I/C) OF THE MINISTRY OF AYUSH (SHRI PRATAPRAO JADHAV)

- (a) & (b) Yes, Sir. National Medicinal Plants Board (NMPB), Ministry of Ayush, Government of India is implementing Central Sector Scheme on "Conservation, Development and Sustainable Management of Medicinal Plants" throughout the country including Tamil Nadu to promote cultivation of medicinal plants and herbs wherein following activities are supported:
  - (i) Information Education & Communication (IEC) activities like Training / Workshops / Seminars/ Conferences etc.
  - (ii) Establishment of nurseries.

- (iii) *In-situ* conservation / *Ex-situ* conservation.
- (iv) Livelihood linkages with Joint Forest Management Committees (JFMCs) / Panchayats /Van Panchayats / Biodiversity Management Committees (BMCs) / Self Help Groups (SHGs).
- (v) Research & Development.
- (vi) Promotion, marketing and trade of medicinal plants produce.
- (vii) Forward and backward linkage in supply chain of medicinal plants (Integrated Component) under which the following activities are supported:
  - Infrastructure for Quality Planting Material to raise the planting material of medicinal plants for cultivation.
  - Information Education Communication (IEC) activities to aware the farmers.
  - Infrastructure for Post-Harvest Management and Marketing to increase the marketability of the medicinal plants, adding value to the produce, increasing profitability and reducing losses.
  - Quality Testing and Certification of raw material.

The National Medicinal Plants Board, Ministry of Ayush, Government of India has approved 494 projects for IEC activities throughout the country including Tamil Nadu to promote the cultivation of medicinal plants from the financial year 2001-02 to 2023-24 including current year under Central Sector Scheme on "Conservation, Development and Sustainable Management of Medicinal Plants". Detail is given at **Annexure – I**.

(c) & (d) Yes, Sir. Ministry of Ayush, Government of India had implemented Centrally Sponsored Scheme of National Ayush Mission (NAM) for cultivation of medicinal plants from the financial year 2015-16 to 2020-21 throughout the country including Tamil Nadu. Till date, Ministry of Ayush had released an amount of Rs. 662.576 lakh and supported 3,931 hectare area under cultivation of medicinal plants, 04 post-harvest management units (storage / godown and drying shed) and 02 Demonstration plots in Tamil Nadu. Detail is given at **Annexure – II.** 

As per the information received from Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) Division, Ministry of Rural Development, Medicinal Plantation is a permissible activity under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS). A joint guideline for convergence with National Medicinal Plants Board (NMPB), Ministry of Ayush and Department of Rural Development, Government of India to promote

medicinal plants under Mahatma Gandhi NREGS had been shared with all States/ UTs for promotion of medicinal plantation in the community and individual land.

The Detail of Medicinal Plantation completed and ongoing and the expenditure made in all States/UTs and under Mahatma Gandhi NREGS since inception (as on 27th November 2024) is given at **Annexure - III**.
