GST Targets

881. Smt. Ranjeet Ranjan:

Will the Minister of FINANCE be pleased to state:

- (a) The total GST collected by the Union Government during the last five years, year-wise and Statewise:
- (b) The total GST retained by the Union Government from the GST collected during that period, yearwise and State-wise;
- (c) Total GST returned to States from the GST collected during that period, year-wise and State-wise; and
- (d) The steps Government is taking to address the shortfall in GST revenue growth, which is falling below the projections outlined in the Union Budget?

ANSWER

THE MINISTER OF STATE IN MINISTRY OF FINANCE (SHRI PANKAJ CHAUDHARY)

(a) & (b): GST collection consists of CGST, SGST or IGST depending upon intra-state or inter-state supply of Goods or services. CGST collected is credited to Consolidated Fund of India (CFI) while SGST collected is credited directly to the Consolidated Fund of respective States. As far as inter-state supply of goods or services including imports is concerned, IGST is being levied and collected by the Centre. The IGST so collected is apportioned / settled between the Union and the States/UTs on monthly basis, on the basis of place of consumption and cross utilization as envisaged under Goods and Services Tax Settlement of Funds Rules, 2017. Depending upon the amount of IGST remaining un-apportioned, provisional/advance settlement is done from time to time on ad-hoc basis between Centre and States/UTs in the ratio of 50:50 and among the States on the basis of monthly revenue to be protected during that Financial Year. Further, 42% of Centre's portion of GST is devolved to states as per Finance Commission formula.

Gross GST (CGST + SGST + IGST+ Cess) collected both by the Union and the States during the last five financial years is given as per Annexure 'A'.

GST retained by the Union Government (CGST + IGST (Centre portion of collection) + Cess) during the last five financial years is given as per Annexure 'B'.

- (c): State's share of GST (SGST + IGST Settlement to States including ad-hoc Settlement) during the last five financial years is given as per Annexure 'C'.
- (d): The Government, on the recommendations of the GST Council, has taken several measures for reforms in GST. These inter-alia include measures for improving tax compliance such as mandating e-way bill, ITC matching, e-invoice for B2C suppliers, deployment of artificial intelligence and machine-based analytics, aadhaar authentication for registration, calibrated action on non-filers, stop filers, targeted assessment-based action on risky tax payer, etc.
