**PM SURYA GHAR PROGRAM**

945. SHRI LAHAR SINGH SIROYA

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) the total number of rooftop solar installations in the country under the PM Surya Ghar Program, State-wise;
- (b) whether the Ministry has any deadline to achieve the target to install 10 million rooftop solar projects across the country, if so, the details thereof;
- (c) whether the Ministry has rolled out any incentives to State Governments or Panchayati Raj Institutions to promote rooftop solar installations in the rural community under the PM-Surya ghar programme, if so, the details thereof; and
- (d) whether there are any challenges in successful implementation of the PM-Surya ghar scheme regarding subsidy disbursements or any other issues and if so, the details thereof?

**ANSWER**

**THE MINISTER OF STATE FOR NEW & RENEWABLE ENERGY AND POWER**

- (a) & (b) The PM Surya Ghar: Muft Bijli Yojana (PMSG: MBY) aims to increase the share of solar rooftop capacity and empower residential households to generate their own electricity. The scheme targets to achieve 1 crore rooftop solar installations in residential sector by FY 2026-27 with an outlay of Rs 75,021 crore. The State/UT wise detail of total no of solar rooftop installations made under the scheme is given at Annexure.
- (c) The Ministry has issued operational guidelines for implementation of component 'Incentives to Local Bodies' under PMSG: MBY on 18/07/2024. The Financial Outlay for the component on Incentives for Local Bodies is Rs 1000 crores @ Rs 1000 per installation. This component aims to incentivize Urban Local Bodies (ULBs) & Panchayat Raj Institutions (PRIs) at the Gram Panchayat level so that they are able to push the deployment of residential rooftop solar within their respective jurisdictions and undertake local mobilization efforts to maximize the number of installations under the PMSG: MBY.
- (d) The Ministry is coordinating with all stakeholders involved such as REC ltd, DISCOMs, vendors, etc to resolve any challenge for successful implementation of PMSG: MBY. As a result, a total of 1.45 crore registrations, 26.38 lakh applications and 6.34 lakh rooftop solar installations have been reported on the National Portal. Subsidy has been released to 3.66 lakh applicants & is regularly getting released within 15 -21 days.
