#### \*148. DR. SYED NASEER HUSSAIN:

### Will the Minister of **WOMEN AND CHILD DEVELOPMENT** be pleased to state:

- (a) the funds allocated and utilized under the BBBP scheme during the last three years, States-wise/UT-wise, including the funds spent on advertisements/media advocacy;
- (b) the number of Sukanya Samriddhi accounts opened under this scheme, State-wise and the amount of money invested in the same;
- (c) the impact assessment of the scheme on the child sex ratio, enrolment and other education-related indicators in targeted districts; and
- (d) the steps taken to address challenges and shortcomings identified in the schemes by reports of the CAG, Parliamentary Committees and other research institutions?

## STATEMENT REFERRED TO IN REPLY TO PARTS (A) TO (D) OF RAJYA SABHA STARRED QUESTION NO.\*148 FOR 12.03.2025 BY DR. SYED NASEER HUSSAIN ON 'EFFECTIVENESS AND IMPACT OF BETI BACHAO BETI PADHAO YOJNA (BBBP)

(a) The "Beti Bachao Beti Padhao" (BBBP) scheme was launched in 22<sup>nd</sup> January 2015 in response to address the issue of gender imbalance and declining child sex ratio. In Mission Shakti guideline implemented from 1 April 2022 ,Beti Bachao Beti Padaho scheme has been expanded to cover all the districts of the country through multi sectoral interventions. BBBP has transformed from a policy initiative into a national movement by mobilizing various stakeholders, including government agencies, media, civil society, and the general public.

Further, Ministry has developed an operational manual which inter-alia includes a thematic calendar for suggested convergence activities at district level with month wise specific themes for holistic development of the Girl Child and to ensure year-round engagement of girls, their families and communities. For example, besides the activities conducted during "Poshan Maah" under Mission Poshan 2.0 by Ministry in the month of September, simultaneously under BBBP, September month is celebrated as National Nutrition Month in convergence with Health Ministry. BBBP is also encouraging greater expenditure on activities that have a ground impact like promoting sports among girls, self-defence camps, awareness about PC-PNDT etc. During the 10th anniversary of BBBP celebration (22<sup>nd</sup> January 2025 to 8<sup>th</sup> March2025) as reported by States/UTs on BBBP dashboard total 4,248 activities were organised which included 9,34,340 participants. In addition, regular Conferences, Seminars, Training etc are also being organised at National level.

State -Wise /UT-wise details of fund allocated and utilized during the last three years under BBBP are at **Annexure I.** 

- **(b)** The total number of active accounts under Sukanya Samriddhi account (SSA) and the total amount deposited in these accounts (as on 31.01.2025) are more than 4.16 Crores and more than Rs. 2.70 lakh crore respectively. State-wise list is at **Annexure II**.
- (c) The latest reports of Health Management Information System (HMIS) of Ministry of Health & Family Welfare (MoHFW) bring out that SRB is showing improving trends and has increased from 918 in 2014-15 to 930 in 2023-24 at national level. State-UT wise SRB as per HMIS data of 2014-15 and 2023-24 is at **Annexure III.**

Further, Gross Enrollment Ratio (GER) of girls in the schools at secondary level has increased from 75.51 percent in (2014-15) to 78 percent in (2023-24) [UDISE-data, MoE]. State-UT wise GER of 2014-15 and 2023-24 is at **Annexure IV.** 

(d) Based on the report of the committee on empowerment of Women (2021-22) on the Subject "Empowerment of Women through Education with special reference to "Beti Bachao Beti Padhao' Scheme in its Fifth Report (Seventeenth Lok Sabha) the Ministry has modified the guideline under Mission Shakti including expending the scheme in all the districts of the country by encouraging greater expenditure on activities that have a ground impact like promoting sports among girls, self-defence camps, awareness about PC-PNDT etc.

Further, BBBP dashboard has also been developed for real time monitoring of the activities conducted at district and State/UT level. Ministry issues regular advisories and reviews the scheme through video conferencing from time to time with officials of States/UTs. Regular field visits are also undertaken by senior officers to review implementation of the scheme on ground. State/UT - wise detailed reviews are conducted during Programme Approval Board meetings, in which Ministry reviews the progress of the State/UT.
