(a) the number of National Sports Federations in the country;

(b) in what manner these federations are regulated;

(c) the specific rules and guidelines for each of these federations;

(d) whether elections are conducted to all of these federations; and

(e) the tenure of the elected members, federation-wise?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (e) OF RAJYA SABHA STARRED QUESTION NO. 211 TO BE ANSWERED ON 20/03/2025 REGARDING "SPORTS FEDERATIONS IN THE COUNTRY" ASKED BY SHRI RAGHAV CHADHA, HON'BLE MEMBER OF RAJYA SABHA.

(a) Sir, the Government of India recognizes one federation each for a particular sport annually as the National Sports Federation NSFs for its promotion and development as per the procedure laid down in the National Sports Development Code of India, 2011 ("The Sports Code"). A total 45 NSFs were granted annual recognition by the Government for the year 2024 for different sports.

(b) & (c) Governance and management of the NSFs is, at present, regulated in terms of the Sports Code, which is an amalgamation of instructions and guidelines brought out by the Ministry of Youth Affairs & Sports. The Sports Code requires the NSFs to follow healthy management practices, accountability, transparency, impartial and transparent selection procedures, age and tenure restrictions of office bearers, basic universal principles of good governance in sports, proper accounting procedures, prevention of age fraud & sexual harassment of women, and holding of elections as per model election guidelines. The Sports Code is available on the website of the Ministry of Youth Affairs & Sports, i.e. https://yas.nic.in.

(d) & (e) The NSFs are bodies registered under the Societies Registration Act, 1860 / State Societies Registration Act, Companies Act, etc. and the elections to the Executive Committees of the NSFs are conducted in accordance with their bye-laws / applicable laws. The term of the Executive Committee of each of the 45 recognised NSFs is given in the Annexure.
