- (b) the amount spent by the Union government for the establishment and maintenance of JSS; and
- (c) the number of beneficiaries of JSS, year-wise and State-wise details for the last three years?

(a) The Jan Shikshan Sansthan (JSS) Scheme, initially launched as Shramik Vidyapeeth (SVP) in 1967, aims to provide skill training in a non-formal mode at the doorsteps of the beneficiary through registered Societies (NGOs) with 100% grant from the Government of India. The objective of the scheme is to increase the household income by promoting self/wage employment through skill development training. The main target of the JSS is to impart vocational skills at the door steps to the non-literates, neo-literates and persons having rudimentary level of education up to 8th standard and school dropouts up to 12th standard in the age group of 15-45 years.

The scheme was transferred to Ministry of Skill Development and Entrepreneurship (MSDE) in July 2018. A total of 304 Jan Shikshan Sansthans have been established in the country till 28th February 2025, the details of which is given at *Annexure-I*. Out of these 304 JSSs, 289 JSSs are operational in the current FY 2024-25.

(b) The JSS scheme is implemented through NGOs with a lump-sum Grant-in-aid on annual basis and one-time non-recurring grants-in-aid of ₹20 lakh at the time of sanction of new JSS from the MSDE. The annual recurring grants-in-aid of ₹50 lakh are provided to meet the Emoluments, Programme Expenses, and Office Expenses.

Since the transfer of the scheme from July 2018 till 28th February 2025, a total of ₹806.35 Crore has been spent under the JSS scheme across the country.
