STATUS OF AB-PMJAY AND ABDM IN PUNJAB

27 SHRI VIKRAMJIT SINGH SAHNEY:

Will the Minister of Health and Family Welfare be pleased to state:

- (a) the details of funds sanctioned, allocated and utilized under Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) and Ayushman Bharat Digital Mission (ABDM) in the State of Punjab during the last three years;
- (b) the number of AB-PMJAY cards created under the scheme in Punjab, so far;
- (c) the number of people benefited within the State under these schemes for primary, tertiary and secondary care including the quantum of funds utilized for their treatment in last three years, year-wise, district-wise; and
- (d) the list of empanelled hospitals including Private hospitals under these schemes in Punjab, district-wise?

STARRED QUESTION NO. 27 * FOR 4TH FEBRUARY 2025**

(a): Ayushman Bharat - Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) is a flagship scheme of the Government which provides health cover of Rs. 5 lakh per family per year for secondary and tertiary care hospitalization to approximately 55 crore beneficiaries corresponding to 12.37 crore families constituting economically vulnerable bottom 40% of India's population. Recently, the scheme has been expanded to cover 6 crore senior citizens of age 70 years and above belonging to 4.5 crore families irrespective of their socio-economic status under AB-PMJAY with Vay Vandana card.

The funding of AB-PMJAY is entirely demand driven. NHA releases funds for scheme implementation to the States/UTs on the basis of the actual demand received from them. There is no State/UT-wise allocation of funds. As per the defined process, States/UTs are required to furnish a Utilization Certificate of previously received funds prior to every new fund release.

The details of funds released to the State of Punjab under AB-PMJAY during the last three years are as under:

(b) As on 30.01.2025, a total of 87.94 lakh Ayushman cards have been created in the State of Punjab under AB-PMJAY including Vay Vandana cards.

(c) AB-PMJAY provides health cover of Rs. 5 lakh per family per year for secondary and tertiary care hospitalization and does not cover primary health care. The financial year-wise and district-wise details of hospitalization in the State of Punjab in the last three years under the scheme are at **Annexure-I**.

(d) As on 29.01.2025, a total of 771 hospitals are empanelled under AB-PMJAY, including 553 private hospitals, in the State of Punjab. The list of hospitals empanelled can be accessed through the following link:
