Increase in drug production under the National AYUSH Mission

329 # Shri Neeraj Dangi:

Will the Minister of AYUSH be pleased to state:

- (a) whether there has been an increase in the production of AYUSH medicines and supplements under the National Ayush Mission, if so, the details thereof;
- (b) the details of institutions established to track the safety and efficacy of AYUSH medicines; and
- (c) the number of AYUSH Health and Wellness Centres functioning across the country under the National AYUSH Mission, the State-wise details of the funds provided by Government to the State Government during the last three years

- (a) to (c) A Statement is laid on the Table of the House.

The Statement referred in reply to Rajya Sabha Starred Question No. 329 for 01.04.2025

(a) Public health being a State subject, the subject matter related to increase in the production of Ayush medicines and supplements comes under the purview of respective State Government. However, Ministry of Ayush is implementing the Centrally Sponsored Scheme of National Ayush Mission (NAM) through State/UT Governments and supporting their efforts by providing financial assistance for supply of medicines to Ayush health facilities, so that better health services may be provided to the community through different Ayush interventions including distribution of medicines.

(b) Rule 160 A to J of the Drugs and Cosmetics Rules, 1945 provides the regulatory guidelines for approval of Drug Testing Laboratory for carrying out such tests of identity, purity, quality and strength of Ayurvedic, Siddha and Unani drugs as may be required under the provisions of these rules, on behalf of licensee for manufacture of Ayurvedic, Siddha and Unani drugs. As on date, 34 State Drug Testing Laboratories have been supported for strengthening their infrastructural and functional capacity. Further, 106 laboratories are approved or licensed under the provisions of Drugs and Cosmetics Rules, 1945 for quality testing of Ayurvedic, Siddha and Unani drugs and raw materials. Drug Inspectors of States/UTs collect medicine samples regularly from manufacturing firms or sale shops within their jurisdiction and send it to Drug Testing Laboratory under Drug Control department for quality testing and if any sample is found to be Not of Standard Quality, appropriate action is initiated as per Drugs and Cosmetics Act 1940 and Rules made thereunder.

Pharmacovigilance Centres for Ayurveda, Siddha, Unani and Homoeopathy (ASU&H) Drugs set up in different parts of the country under the Central Sector Scheme-Ayush Oushadhi Gunavatta evam Utpadan Samvardhan Yojana(AOGUSY) are mandated to report adverse drug reaction through a three-tier structure comprising of a National Pharmacovigilance Co-ordination Centre (NPvCC), Intermediary Pharmacovigilance Centres (IPvCs) and Peripheral Pharmacovigilance Centres (PPvCs). The details of Pharmacovigilance Centres for Ayurveda, Siddha, Unani and Homoeopathy (ASU&H) Drugs are furnished at **Annexure -I**.

(c) Under NAM, as per the proposals received from State/UT Governments through their State Annual Action Plans (SAAPs), 12,500 units of Ayushman Arogya Mandir (Ayush) [AAM (Ayush)] have been approved for operationalization by upgrading existing Ayush dispensaries and Sub health Centres. The State/UT-wise status of approved and functional AAM (Ayush) is furnished at **Annexure- II**. Further, the State/UT-wise status of funds released for AAM (Ayush) during last three years is furnished at **Annexure -III**.
