Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:-

- (a) whether it is a fact that de-addiction centres are functioning in the country;
- (b) if so, the details of de-addiction centres for people suffering from alcohol and drug addiction in the country, State-wise;
- (c) the number of persons suffering from the said addictions admitted in these centres during each of the last three years;
- (d) whether any financial aid or other assistance is given to the families of the persons suffering from the said addictions; and
- (e) if so, the details thereof?

- (a) & (b) The State-wise details of alcohol and drug de-addiction centres, supported by Department of Social Justice and Empowerment, is at Annexure-I.
- (c) The State-wise number of persons who have benefitted from these centres during last three years, is at Annexure-II.
- (d) & (e) No direct financial support is provided. However, counseling services and medicines are being provided free of cost to the families of the persons suffering from the alcohol and drug addiction at de-addiction centers supported by this Department during the period of treatment as well as during home visits after discharge from the deaddiction centers.

The Department has developed Navchetna Modules (A New Consciousness on Life Skills and Drug Education for School Children) teacher training modules. These modules are implemented by teachers to enhance awareness and education on life skills and drug prevention among school students. The Navchetna modules also have drug education information session for parents and family.
