- (a) the details of the number of houses constructed under Pradhan Mantri Awaas Yojana Gramin (PMAY-G) during the last three years and the current year across the country, State/UT-wise including Puducherry;
- (b) the funds sanctioned, allocated and utilized under the scheme during the said period, State/UT-wise including Puducherry;
- (c) the details of the targets set and achievements made under the scheme so far; and
- (d) the details of the number of houses allocated to the poor and people living below poverty line under the scheme, so far?

“STATUS OF IMPLEMENTATION OF PMAY-G”**

(a): The details of the number of houses constructed under Pradhan Mantri Awaas Yojana Gramin (PMAY-G) during the last three years and the current year across the country, State/UT-wise is at **Annexure-I**. The UT Administration of Puducherry has not been implementing the scheme since its inception i.e. 1.04.2016.

(b): The funds released and utilized under the scheme during the last three years and the current year ,State/UT-wise is at **Annexure-II**.

(c): In order to achieve the objective of "Housing for All" in rural areas, the Ministry of Rural Development is implementing Pradhan Mantri Awaas Yojana- Gramin with effect from 1st April 2016 to provide assistance to 4.95 crore eligible rural households with basic amenities by March 2029. As on 01.02.2025, a cumulative target of 3.79 crore houses have been allotted to States/UTs out of which 3.28 crore houses have been sanctioned and 2.69 crore houses have been completed.

(d): The beneficiaries under the scheme are identified on the basis of housing deprivation parameters and exclusion criteria prescribed under Socio Economic Caste Census (SECC) 2011. These parameters/criteria are applied both on SECC 2011 and “Awaas+” survey databases and then they are further subjected to due verification by Gram Sabha and an appellate process thereafter.
