- (a) the number of maternal deaths, stillbirths and newborn deaths in the last three years, State/UT-wise;
- (b) whether Government is organizing awareness camps and pregnancy-related health camps in rural areas as almost 16 per cent of Indian women are not receiving any form of healthcare during their pregnancy;
- (c) if so, the details of the budgetary expenditure under Pradhan Mantri Surakshit Matritva Abhiyan (PMSMA) for the last three years; and
- (d) the number of beneficiaries under PMSMA, in the last three years, State-wise and vear-wise?

(a) The details of Maternal Mortality Ratio (MMR), Still Birth Rate (SBR), and Neonatal Mortality Rate (NMR) as per the latest available data, State/UT-wise are placed at Annexure-I, Annexure-II, and Annexure-III

Over the past 30 years, the Maternal Mortality Ratio (MMR) in India has declined by 83%, compared to the global reduction of 42%.

Similarly, the Neonatal Mortality Rate (NMR) in India has reduced by 65%, surpassing the global reduction of 51%.

- (b) The Government of India in collaboration with States and Union Territories, conducts various pregnancy-related activities through health and awareness camps across the country including rural areas, such as Monthly Village Health Sanitation and Nutrition Day (VHSND), Health Melas, Ayushman Arogya Shivir, Outreach Reproductive and Child Health (RCH) camps, Mobile Medical Units (MMU) and Pradhan Mantri Surakshit Matritva Abhiyan (PMSMA) activities.
- (c) The details of budgetary expenditure under Pradhan Mantri Surakshit Matritva Abhiyan (PMSMA) during the last three years are given in the table below;
