UDYAM SCHEME

112. SHRI R. DHARMAR:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the features of the Udyam Scheme;
- (b) the details of the funds sanctioned, allocated and utilised under the scheme across the country including the State of Tamil Nadu;
- (c) the number of Micro, Small and Medium Enterprises (MSMEs) registered on Udyam Portal within the State of Tamil Nadu;
- (d) the details of the key achievements of this scheme across the country; and
- (e) whether this scheme has proved a major milestone for MSMEs sector in the country, the details thereof?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES

(a): On 1st July, 2020, the Ministry of Micro, Small and Medium Enterprise (MSME) launched Udyam Registration Portal (URP), a free of cost online platform, on which an enterprise can register itself as an MSME.

(b) & (c): As the URP is free of cost, no funds are sanctioned or allocated. The State/UT-wise details of MSMEs registered on across the country, including the State of Tamil Nadu, as on 29.01.2025 are given at Annexure-I.

(d) & (e): Udyam has provided an identity to the MSMEs and has become an enabler for the MSME Sector across the country. An enterprise after registering on the URP becomes eligible to avail the benefits of the Schemes of the Ministry, subject to meeting the eligibility criteria defined in the guidelines.
